

## **Why is our Government working to kill us?**

## **How can we fix our horrible, unconstitutional Government and save ourselves?**

The unconstitutional Government of the United States of America funds gain of function research and released instructions for anyone to create more deadly viruses. They give money to potential enemies like China to help them develop deadly new viruses. They lie about the inevitable H5N1 pandemic coming (partly due to this gain of function research), and refuse to warn or prepare Americans for this inevitable, potentially imminent, deadly pandemic and the collapse that will result. They refuse to harden our fragile electric grid that is vulnerable to destruction by thousands of enemy agents in the country, solar flares, cyber-attacks, or small nuclear attacks that North Korea, China, or Russia can easily execute. Despite experts warning that 90% of Americans could die, the campaign donations of utility company lobbyists and fear of losing votes from higher electric rates keeps career politicians from doing the right thing to protect our lives.

Our government provides collapse survival protection for top elected and government officials at Mount Weather and other sites—but provides no civil defense for citizens.

Not only does the government stockpile survival food just for top government officials and politicians, not citizens, Executive Orders allow them to steal food from citizens if they need more! No, this is not a fabricated conspiracy theory, it is found in decades of Executive Orders. Government agencies are authorized to steal food and resources from citizens in a collapse—their #1 priority is protecting themselves. Citizens are not just expendable, they are exploitable—a resource for Government to raid if their stockpiled supplies run low.

The unconstitutional, unlimited cesspool of regulations at all levels of governments don't just damage the economy and inflict losses that cost people income, jobs and lifespan, they make it increasingly harder for civilians to prepare for collapse survival.

This paper goes through 30, documented examples of how our government is working to kill us.

In public history textbooks, written by taxpayer funded professors, Big Government politicians are the good guys, fighting against evil, greedy businessmen. The “Iron Triangle” is the official political science term for the bad alliance of government bureaucrats, elected career politicians, and special interest group/business lobbyists working together to promote their profits and interests. Big businesses and campaign donations to politicians are indeed often very bad, but there is a far worse alliance that has destroyed good American constitutional government and personal liberty: the “Perverted Triangle” of government bureaucrats, career politicians, and lawyers. The latter two are often the same person—attorneys in legislatures that pass laws and regulations that generate more business and income for fellow lawyers, more laws and regulations and jobs for government bureaucrats, more campaign donations and power for the politicians. And many Perverted Triangle members become lobbyists.

Constitutional limits to federal government interference in social matters and personal economic affairs were illegally eliminated in 1937 when a majority of Supreme Court Justices surrendered to pressure and threats from President Franklin Roosevelt (FDR). Later Democratic Administrations, along with Republicans, let the Perverted Triangle surge in power with massive increases in

unconstitutional social and welfare programs, an explosion of laws and regulations, undermining families and personal responsibility, dividing the nation.<sup>i</sup>

There is not a government conspiracy to deliberately kill citizens. But because of lobbyists, career politicians always running for re-election and prioritizing campaign donations and votes, the lack of any Constitutional limits to government spending and policy since FDR coerced the Supreme Court into abandoning Constitutional limits to government, a new very bad system of government has evolved. The end to Constitutional limits on government has led to massive growth in political power, career politicians, an entrenched, self-serving government bureaucracy, uncountable thousands of new laws and regulations benefiting lawyers. Today any program or regulations with billionaires or an influential interest group behind it can be passed--even when it threatens and takes the lives of the silent majority.

The Perverted Triangle has approved a multitude of unconstitutional, divisive social programs that benefit them, but divide the nation and threaten civil war. The socialist, welfare state the Perverted Triangle has built undermines marriage and families, promoting a subservient, irresponsible populace, higher crime, long-term poverty and dependence, and a higher domestic homicide death rate. Big Government overspending is driving national debt to a level that will bankrupt the country and lead to an economic collapse. Millions of government social and welfare workers are hired because they generate votes--while not enough police or Army National Guard members for peacetime security or collapse recovery operations are funded since there is no big lobby group and campaign donations behind them.

The Perverted Triangle and the elimination of Natural Rights and limits to Government have yielded a socialist state and a dependent population that will largely not survive a collapse.

The worst result of unlimited Government and the Perverted Triangle is that government no longer does it's proper job of protecting citizens from threats they cannot handle on their own. Simply put, the Perverted Triangle's now unlimited power and focus on their political battles, pandering for votes and their benefit, leads to hundreds of thousands of citizens being killed annually now, and Americans set up for annihilation in a collapse.

Without an end to the Perverted Triangles unlimited power and focus on re-election and pandering for votes with pork and social programs rather than prioritizing national security, dividing our country, most Americans, and likely the vast majority of all humans around the world, are unlikely to survive the coming collapses.

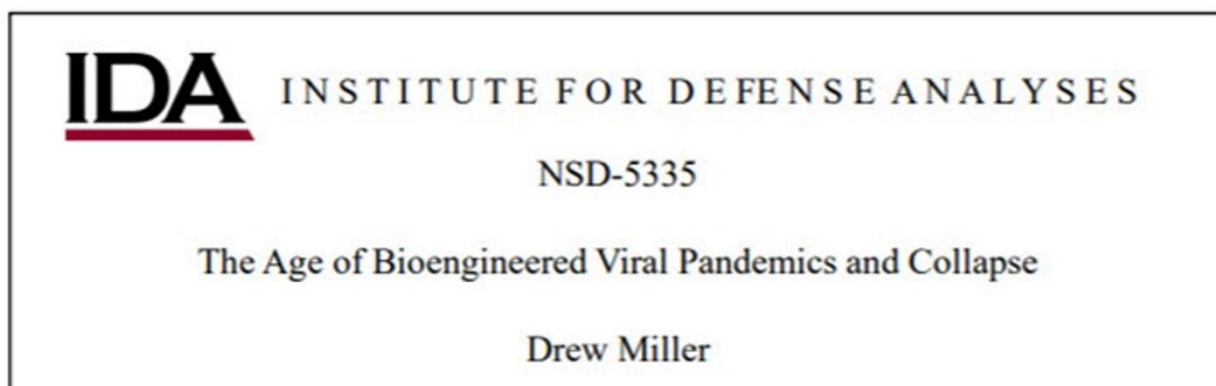
5. Refusing to stop or even retaliate against enemy cyber-attacks on critical infrastructure

9. Risking nuclear war with China by backing Taiwan despite China’s legitimate claim
10. Risking nuclear war by pushing NATO membership to Russia’s border despite Russia’s clear threats of retaliation, prompting war in Ukraine
11. Funding, promoting AI despite clear evidence that it will lead to more weapons of mass destruction and inevitable misuse to kill millions or all of us.
12. Eliminating battlefield nuclear weapons, endangering troops deployed overseas for domestic political votes
13. Providing collapse survival protection just for top elected and government officials at Mount Weather and other sites—but no civil defense for citizens

### **1. Funding Gain of Function Research to develop more deadly viruses—and releasing instructions on how to do this to enemies/terrorists**

The December 2016 issue of The American Interest policy journal and an Institute for Defense Analyses report warned that we have entered the “Age of Bioengineered Viral Pandemics and Collapse.”<sup>ii</sup>

Experts say natural or bioengineered viral pandemics are inevitable due to new technologies that make it easy to modify an existing virus, making it more lethal or transmissible. As an Institute for Defense Analyses, a Dept of Defense Federally Funded R&D Center (think tank) report warned, through bioengineering a lone terrorist or a Revolutionary Guards lab in Iran can create deadly new viruses. Dr. Tara O’Toole, former director of Johns Hopkins University Center for Civilian Biodefense Strategies, warned in Congressional testimony: “We are in the midst of a bioscientific revolution that will make building and using biological weapons even more deadly and increasingly easy.” Avian Flu, H5N1, historically 50-60% lethal, modified to be human to human transmissible, could cause a pandemic that kills a billion people.<sup>iii</sup>



Our government funded “Gain of Function” research in H5N1 a decade ago that was successful in getting mammal to mammal transmission of the virus in ferrets—mammals selected because their respiratory system is very similar to ours. Worse, they published how they did this for any other nation, terrorist group, or individual to pursue.<sup>iv</sup>

## US: Don't publish lab-bred bird flu recipe

**WASHINGTON** — The U.S. government asked scientists Tuesday not to reveal all the details of how to make a version of the deadly bird flu that they created in labs in the U.S. and Europe.

The lab-bred virus, being kept under high security, appears to spread more easily among mammals. That's fueled worry that publishing a blueprint could aid terrorists in creating a biological weapon, the National Institutes of Health said.

Bioengineered viruses are the ideal weapon. Compared to nuclear weapons they can be more deadly, orders of magnitude cheaper and easier to create and launch, and, most importantly, offer the ability to attack with impunity to retaliation since we may not know and can't prove who released the virus. Whether created and released by a terrorist group or one dedicated individual, a bioengineered virus could cause both a pandemic and, as people react, a "collapse": economic activity ceases, law and order breaks down as people start looting, marauding to avoid starvation.

When a bad pandemic or any big disaster strikes, law and order will quickly vanish in cities, and eventually everywhere. When the availability of food and water is threatened, widespread marauding will occur. In 1977, New York City suffered a lightning strike that caused a power failure for one night. Over 3,000 arrests were made for looting, 400 policemen were injured, and 500 fires were started. After Hurricane Katrina, looting spread rapidly throughout New Orleans, often in broad daylight and in the presence of police officers. Many of the city's police officers deserted their posts. The ensuing violence scared truck drivers, with many refusing to go into New Orleans without military escort. An H5N1 pandemic will likely be the worst disaster our species has experienced, with the virus killing perhaps a billion—and the collapse it creates far more as people

die of starvation or are killed by marauding groups stealing to survive. Whatever triggers the collapse, when there is no food in grocery stores and people fear starvation, they will start looting, law and order will quickly vanish, and the collapse that results could kill far more than the initial trigger event.

## **2. Giving money to China to help them develop deadly new viruses**

The National Institute of Health and Dr. Anthony Fauci denied funding studies that would make a coronavirus more dangerous to humans, but documents obtained from a Freedom Of Information Act lawsuit show that this was a lie. Richard Ebright, Professor at Rutgers University and laboratory director at the Waksman Institute of Microbiology, said the documents show "unequivocally" that National Institute of Health (NIH) grants were used to fund controversial gain-of-function research at the Wuhan Institute of Virology in China. Ebright said: "The documents make it clear that assertions by the NIH director, Francis Collins, and the NIAID director, Anthony Fauci, that the NIH did not support gain-of-function research or potential pandemic pathogen enhancement in Wuhan are untruthful.<sup>v</sup> USAID was at least one of the vehicles used to fund Chinese research to make more deadly, more transmissible viruses.<sup>vi</sup>

Senator Rand Paul questioned and condemned Dr. Fauci in 2020 Senate testimony for funding Chinese government research at Wuhan, with Dr. Fauci denying and insulting the Senator for the accusations. On his last day in office, one of his final acts as President, Biden issued a pardon to protect Dr. Fauci.

Gain of function research has some legitimate value in producing a valuable product or obtaining samples to develop vaccines, but with great dangers. Former Center for Disease Control (CDC) Director Redfield has condemned gain of function research as too risky and called for an end to it, but the biologists and scientists and government officials who fund them of course want it continued despite the risks of its misuse to create a deadly pandemic.<sup>vii</sup>

The U.S. government providing funds and assisting biological research of a foreign nation like China that could be preparing to attack and destroy us is absolutely wrong. It's akin to the Government funding tank and dive bomber R&D in Nazi German in the 1930s.

The CDC denied any possibility that bioengineering, man-made experimentation could have led to the Covid-19 pandemic (later proved wrong), and the CDC covered up for years the fact that the U.S. had actually funded "gain of function" research at the Wuhan lab. It is still very difficult to believe that the U.S. government funded Chinese research to make more lethal viruses!

## **3. Lying about the H5N1 threat and refusing to warn or prepare Americans for this inevitable, potentially imminent, deadly pandemic and the collapse that will result**

The H5N1 virus continues to mutate (or is being manipulated by humans) and is now spreading mammal-to-mammal in several species. It will start spreading in human populations at any time, yielding the worst pandemic in human history.

A government trying to protect its citizens would be working to warn and prepare them to survive the inevitable H5N1 pandemic that is coming and other natural or bioengineered pandemics.

Instead, the U.S. Government goes out of its way to assure citizens not to prepare or worry—insisting H5N1 is “low risk.”

The US Centers for Disease Control and Prevention just announced in January 2025 that it is “urging hospitals to accelerate advanced testing of people they suspect may have bird flu.” A U.S. citizen just died from H5N1, and a child in San Francisco has been confirmed to have had H5N1 influenza—with no exposure to animals. There was also a case in Missouri last year of someone testing positive for H5N1 without any known exposure to animals.

The CDC does **not** admit these facts in its H5N1 warnings:

- Mammals that used to catch H5N1 only from contact with infected birds, now are getting H5N1 from other mammals—the virus has mutated to spread in mammal populations
- “H5N1 has affected several mammal species since 2003, thus raising concern because H5N1 mammalian adaptation could represent a risk not only for diverse wild mammals but also for human health.”
- “During 2003–2023, a total of 878 humans tested positive for the H5N1 virus, and 458 deaths were reported, indicating a lethality of  $\approx 52\%$ ”
- “Mutations in the virus found in diverse mammal species, especially in the current panzootic, are of great concern. For instance, the T271A mutation reported in minks in Spain is also present in the H1N1 that produced a pandemic in 2009. . . . Moreover, some infected species, such as minks, may act as a mixing vessel for interspecies transmission between birds, mammals, and humans.”

In sum, mammals are catching and spreading the virus directly to other mammals. When a virus infects mammals they serve as “mixing vessels” that helps the virus find mutations that allow better transmissibility in other mammals—including humans. H5N1 and seasonal flu virus in a human provide a fantastic mixing vessel to help H5N1 mutate to a human-to-human transmissible variant. H5N1 is going to either naturally mutate to be human-to-human contagious (and may already have in some places), or will be bioengineered and manipulated to be human-to-human transmissible as the former Director of the CDC (no longer constrained by elected officials) has warned is even more likely.<sup>viii</sup>

Many biologists are warning that we face an inevitable H5N1 pandemic, that could start now. The Dec 2024 issue of *Science* magazine noted, “No clear human-to-human transmission of H5N1 has been documented yet, but ‘this feels the closest to an H5 pandemic that I’ve seen,’ says Louise Moncla, a virologist at the University of Pennsylvania. ‘If H5 is ever going to be a pandemic, it’s going to be now,’ adds Seema Lakdawala, a flu researcher at Emory University.”<sup>ix</sup>

The CDC is working to get early detection of H5N1 cases in humans in hospitals in hopes they can limit the spread of the virus; hence the January 2025 press release encouraging hospitals to expedite testing and reporting of H5N1 cases. The press release also mentioned CDC investments in a vaccine that would work for H5N1, though as H5N1 continues to mutate, or is deliberately

bioengineered, we cannot be certain if a vaccine would work (just as seasonal flu vaccines often do not work)--or whether or not it is safe, does not have serious bad side effects.<sup>x</sup> In effect, the CDC admits that they are preparing for an H5N1 pandemic, but the CDC **still** continues it's big lie of calling H5N1 "low risk." The CDC knows that a H5N1 pandemic is coming, inevitable—but does not honestly admit this or warn the public. They continue to broadcast the lie that H5N1 is low risk.

Bill Gates, whose foundation is focused on world health issues, recently warned about pandemics, insisting, "we are absolutely not prepared." Gates estimates "the chance of a natural pandemic in the next four years is somewhere between 10 and 15 percent. . . . And it'd be nice to think we're actually more ready for that than we were last time. But so far we're not."<sup>xi</sup>

The former Director of the Center for Disease Control, no longer under political constraints, has defied the continued CDC lie that H5N1 is "low risk" to humans and has warned that an H5N1 pandemic is coming. Unlike the CDC which completely ignores the deliberate human manipulation of H5N1 virus, former CDC Director Redfield also warned that "there is greater risk for the disease to be lab-grown." Redfield noted that "against my recommendation, the scientists that did these experiments actually published them . . . . So, the recipe for how to make bird flu highly infectious for humans is already out there."<sup>xii</sup>

When will the CDC ever admit that H5N1 is an inevitable human pandemic and extremely high risk? Based on recent Covid-19 experience and the political pressure on the CDC not to "panic" citizens or undermine confidence in Big Government to protect them, the answer is they won't until after the pandemic is well underway and it is far too late to get prepared or avoid exposure. The CDC **never** issued a threat alert on Covid-19, months after it had spread out of China and was clearly a developing pandemic.<sup>xiii</sup> They were months late in honestly warning about this pandemic threat, though other sources had long been saying a pandemic would clearly result.

The CDC will continue to lie and claim that H5N1 is "low risk" until the pandemic has started and it's too late to prepare because their priority is not saving American lives, but pleasing the elected officials who control their budget and conducting research.

#### **4. Refusing to harden the electric grid despite Congressional funded studies by experts warning our Grid is highly vulnerable, 90% of Americans could die if North Korea, China, Russia, terrorists, solar flares or other forces take it down**

The vulnerabilities of our fragile electric system have been known for decades, published in Congressional reports, with the Chair of one of these Congressional EMP study commissions, a former Admiral and CIA Director, warning that 90% of Americans could die when our grid is destroyed.<sup>xiv</sup> When the grid goes down, nothing gets produced, municipal water systems do not work, gasoline cannot be pumped, and millions will die in the first month. Law and order will quickly vanish as people desperate to survive, including gang members and millions released from prisons that cannot operate without electricity, steal and kill to obtain food and water.

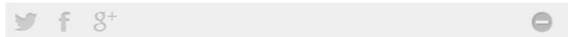

Ex-CIA chief warns against underestimating N. Korea's nuclear arsenal

WASHINGTON, Feb. 28 (Yonhap) – North Korea's nuclear arsenal is believed to be more advanced and dangerous than many experts think, a former CIA director warned Tuesday, calling for more attention to the threats.

James Woolsey, who served as CIA chief from 1993-95, made the point in an article in the Street Journal, saying the communist nation is taking the same path that the U.S. and other powers took, including Israel, South Africa, India and Pakistan.

"History suggests North Korea already has nuclear-missile warheads and a sophisticated nuclear weapons," he said in the joint article with Peter Vincent Pry, executive director of the Task Force on National and Homeland Security.

The North built its first atomic weapon by 1994, more than a decade before testing, though yield of North Korean nuclear tests isn't known, Woolsey said, adding that estimating yield from seismic signals is inexact.

There are many ways to take out the fragile U.S. electric grid, not just a nuclear attack:

### U.S. Electric Grid Vulnerabilities

1. An unstable, old system that spreads problems across the grid
2. Cyber attack
3. Solar Flares, electro-magnetic disturbance from the sun
4. EMP from nuclear weapons
5. Coordinated physical attacks on the system
6. Electric system damage from other disasters, cascading effects

Our enemies know about these electric grid vulnerabilities. Our easy to knock out electric grid is our Achille's Heel. It is not just Russia and China that could launch such an attack, even North Korea's tiny, inaccurate nuclear arsenal is sufficient to destroy our grid. A dedicated terrorist group could take it down with coordinated physical attacks on key nodes.

When the electric grid goes down, U.S. military power goes down as well. Strategic nuclear forces are more robust, but the vast majority of our military power will vanish when we lose electric power, since the military uses the civilian electric grid. If you see diesel backup generators somewhere, you're looking at maybe a few days of power and then nothing. Solar farms and wind

generators might be destroyed, but even if not—without the transformers that can be destroyed by a wide variety of attacks, you can't transmit power, the grid is dead, and will be for years. The estimates are at least a year, and many experts believe the timeframe is a long period of many years—assuming some overseas help. Unfortunately, the U.S. produces relatively few transformers, and thousands would have to be replaced if there is a big attack on our grid.

Yet elected officials refuse to force utilities to harden our grid from EMP, cyber, and physical attack because they fear losing votes for utility rates going up, and they prioritize donations from utility company lobbyists for their re-election campaigns over protecting citizens. Nor do they face the risk of death when the grid goes down—Congressmen and top government officials will be sheltered at Mount Weather and Raven Rock while the rest of us are left to fend for ourselves. Elected officials choose campaign donations from utility lobbyists over the lives of citizens.

## **5. Refusing to stop or even retaliate against enemy cyber-attacks on critical infrastructure**

Russia has demonstrated its ability to take down electric grids and critical infrastructure in Ukraine and against other countries. The FBI director warned in 2024 that China has placed malware on hundreds of thousands of U.S. computers, internet routers, and systems, targeting military, government, and critical infrastructure. The former chairman at electric power operator Southern Company says China's cyber attack capability is now an existential threat for American companies and government agencies.<sup>xv</sup>

But without government requirements to be protected, utility systems focus on competing to deliver low cost electricity, and are expanding with more digitalized systems that are more vulnerable to cyber attack. The number of susceptible points on U.S. electrical networks have been increasing by about 60 per day. There were over 1,000 cyberattacks on U.S. utilities in 2024, 70% more than prior years.<sup>xvi</sup>

Despite repeated, damaging cyber-attacks that we know China, Russia, Iran, and North Korea have launched over the past decades, there is no retaliation for these preparations for and acts of war.<sup>xvii</sup> As an NBC News report noted, "The Obama administration finds itself stymied by its own failure to formulate a framework for responding to cyber-attacks, despite years of serious and damaging intrusions."<sup>xviii</sup> In December 2024, China hacked into U.S. Treasury Department systems, but there were no retaliations or repercussions for these cyber-attacks.

There is no public warning that our enemies are readying or already have the capability to cripple U.S. utilities, but former U.S. officials interviewed warn that countries like China have the capability to "disrupt our ability to support military activities or to distract us, to get us to focus on a domestic incident at a time when something is flaring up in a different part of the world."<sup>xix</sup>

## **6. Failure to prevent thousands of foreign agents in the U.S. that can destroy military assets, our electrical grid and other critical infrastructure**

There are thousands of Chinese agents in the U.S., in every state, and thousands of other Russian, Iranian, North Korean, ISIS and Al Qaeda agents who are here to execute terrorist attacks or possibly large scale operations that could inflict severe damage.<sup>xx</sup>

When our electric grid goes down, the economy does not function, municipal water systems do not work, and Congressional Commissions have concluded that 90% of our population could die. Our military bases depend on the civilian electric grid. If it goes down, our conventional military power collapses too.

Since our electric system is the “Achilles’ Heel” of not just our population, but our conventional military power, and a highly fragile system, we believe that foreign agents and terrorists will target the grid as the obvious, easy way to disable our military and kill most of our citizens. Foreign agents are very likely working in electric utility companies, placed for sabotage.

Taking out many of the 700 extremely high voltage (EHV) transformers that carry electric power (most of it) over long distances, and other critical nodes on the grid with cyber-attacks, physical attacks by agents on the ground, and drone attacks from the air, would be a very feasible and effective attack. There have been several attacks on electric grid substations and transformers in the U.S. over the past decade, some of which appear to have been professionally executed group attacks for training or planning. There have been cyber-attacks on our grid, clear evidence that our enemies are working to develop capability to destroy it.

Enemy agents can poison municipal water systems, execute physical attacks on all kinds of critical infrastructure beyond the electric grid.

Enemy agents can easily start hundreds, thousands of wildfires, as well as execute arson attacks in large, crowded buildings. With low probability of getting caught or stopped, a single agent could start dozens, hundreds of fires. With so many fires raging at once, most fires would burn without any firefighting resources to put them out.

Despite thousands of foreign agents in the U.S., the government is not waging an aggressive, effective campaign to discover and arrest them, or even warning the public that we face a threat of thousands in our midst that can destroy critical infrastructure, start fires, and kill us.

## 7. Failing to stop enemy drone surveillance of military bases and critical infrastructure



In December 2023, large numbers of unidentified air vehicles flew for weeks over Langley Air Force Base, where our most advanced jet fighters, F-22 and F-35s are based. Air Force Gen. Mark Kelly was called out to observe dozens of UAVs doing complex and coordinated flights, well beyond the sophistication of civilian drone operations. Some drones were 20 feet long and flying at more than 100 miles an hour, at altitudes of 3,000 to 4,000 feet. In addition to Langley, the UAV or drones overflew Naval Station Norfolk, our largest naval port. The *Wall Street Journal* reported similar UAV surveillance over many other sensitive military sites, that the Department of Defense could not explain. Due to federal laws, the military cannot shoot down UAVs over bases unless they pose an immediate threat. The DoD never determined the UAVs' origin or who controlled them.

The Government's continued assurances to the public that the drones are not a threat, not foreign controlled, are clearly false—if we don't know who controlled drones conducting surveillance of a military base and critical electric infrastructure we obviously cannot say they are not foreign and not a threat. Common sense and good judgment clearly call for the opposite conclusion—that they likely were conducting surveillance and targeting for a very serious, capable enemy.

There are several Chinese air drone companies operating in the U.S. Chinese agents are probably working in these air taxi drone “front companies” conducting surveillance operations under cover of a legitimate commercial company's development operations. If caught, the company explains that they were doing R&D work, and are understandably trying to keep their commercial R&D work confidential.

In addition to drone surveillance of military bases, drones appeared to be mapping electric grid stations and municipal water sources. The recent FAA drone bans in NY and NJ included limits

over transmission lines and power substations. Large drones dispatching smaller drones with explosive charges could easily destroy a large number of transformers.

Drones are ideal vehicles to place small charges to attack advanced aircraft on the ground (that cost millions of dollars each, and are very few in number as a result)—or destroy huge transformers to take out our electric grid. A massive drone attack on military bases and/or the electric grid would take extensive reconnaissance and mapping for a large fleet of drones to execute a big attack—activity that has occurred across the U.S. over the past year.

Since our vulnerable electric system is the “Achilles’ Heel” of not just our population, but our conventional military power, foreign agents and terrorists will likely target the grid as the obvious, easy way to disable our military and kill most of our citizens. Foreign agents working under cover in electric utility companies, Chinese agents hiding/operating in Chinese air taxi drone companies to launch drone attacks on transformers, along with attacks by small Chinese agent teams on key substations and transformers could enable China to destroy the electric grid, cripple the U.S. military, and kill most of us.

In February 2023, we shot down a Chinese surveillance balloon, but only after it has drifted across the U.S. As with cyber-attacks, drone incursions, and enemy agents in the country, there is no penalty for enemy preparations to attack the U.S.

Enemies are wisely preparing the capability to destroy our electric grid without providing obvious evidence that they launched the attacks. Cyber and physical attacks (from agents on the ground and drones in the air) can disable a large part or the vast majority of our electric grid, removing the U.S. as the world’s top superpower.<sup>xxi</sup>

If Chinese or Russian agents conduct the attacks, China or Russia would deny it—and likely convince much or most of the world that any evidence the U.S. did present is not conclusive. Nor do we benefit from launching strategic nuclear strikes to punish them after we’ve lost our grid—virtually guaranteeing retaliatory nuclear attacks by them, adding nuclear devastation to our country at a time when hundreds of thousands to millions are dying daily in the aftermath of a grid down disaster.

## **8. Failure to secure borders—allowing enemy agents, terrorists, released prisoners, millions of undocumented immigrants easy access to the country**

There are an estimated 12 million illegal immigrants in the U.S. today, over 3% of the population.

There was a huge surge in Chinese nationals crossing easily through our largely unsecured southern border in recent years. The House Committee on Homeland Security released a report that over 24,000 were apprehended illegally crossing the border. Of course, a much larger number could have gotten across without being caught. Countries like Cuba, Haiti, Nicaragua, and Venezuela have done mass paroles of criminals and then helped them get to the U.S. to illegally enter our country.<sup>xxii</sup>

# Chinese illegal immigration on pace to break records at US southern border

Officials, lawmakers raise national security concerns about spike in Chinese nationals

We do not know how many Americans have been killed by illegal immigrants for several reasons. First, the government does not collect immigration status data in arrest records, with the exception of Texas. Second, with no records or knowledge of an illegal alien in the country, a murder they commit without an arrest would not be attributed to them. There were 346,000 cases of homicide and non-negligent manslaughter unsolved from 1965 to 2023.<sup>xxiii</sup> Finding an enemy agent or a criminal illegal alien is much harder than apprehending a registered, documented, far easier to track citizen.

About half of murders/homicides in the U.S. are never resolved, they can't find or prove who committed the crime. Many of these deaths are likely due to illegal immigrants and enemy agents. With no records of them, no fingerprints on file, no known address, they are far more difficult to catch. Trained agents and experienced criminals in particular, will be very good at avoiding arrest. In 2023, the rate of unsolved murders in the U.S. went up, possibly due to the rise in illegal immigrants and enemy agents in the U.S. The "data" showing low crime rates for illegal immigrants is nonsense—we can't know their propensity to do more or less crimes since they are undocumented, unknown. We can reason that with foreign countries releasing/exporting criminals to the U.S. and enemy countries sending agents to the U.S., that these people are likely to kill citizens, and not get caught doing it.

## 9. Risking nuclear war with China by backing Taiwan despite China's legitimate claim

China colonized and annexed Taiwan in the 1600s, but later had to cede control to Japan in 1895, gaining it back after Japan's surrender in 1945. The "Republic of China" led by the Nationalist Party took control of Taiwan in 1945. The Nationalist Party lost to the Communist Party in China's 1945-1949 civil war, taking refuge with over 1 million Chinese on Taiwan which is still called the Republic of China. Over 95% of Taiwan's population today is Han Chinese ethnicity. The People's Republic of China's position is that this is an internal Chinese matter, finishing their civil war--a very legitimate claim. Thanks to George Marshall's brilliance and integrity, the U.S. stayed out of China's civil war. But scum Senator Joseph McCarthy and political pandering for votes led to a resolution in 1955 that gave the POTUS authority "to employ the Armed Forces of the United States as he deems necessary" to protect Taiwan.<sup>xxiv</sup>

Since 1949 the Chinese Government has insisted Taiwan is their territory and they will put it under their control. The U.S. backing Taiwan has been extremely popular position for U.S. politicians, not wanting to look like they are "appeasing" a Hitler, suggesting strength in standing up to and fighting communism. The Hitler expansion analogy does not fit. China taking Taiwan is not Germany invading Poland, and does not lead to attacks on Japan or South Korea or an invasion of the Philippines.

China will pressure or if necessary invade Taiwan to reclaim this territory, and if the U.S. follows through on promises to assist Taiwan we must expect that China will engage in “nuclear chicken” against us—threatening and if necessary firing some nuclear weapons against the U.S. to force the POTUS to back down. China has been preparing for war with Taiwan for half a century, and will very likely take Taiwan, possibly soon. Taiwan has had time to prepare its defenses or negotiate a deal with the PRC. To avoid loss of Taiwan’s hugely valuable computer chip plants, China would very likely seek to negotiate a reunion rather than invade. No outside nation has any obligation or good reason to oppose China handling their domestic affairs, settling their civil war. Governments are supposed to prioritize defending their citizens. The U.S. government should prioritize protecting the citizens that elected and support them, not subjecting them to high risks of nuclear attack to defend Taiwan.

If we get into war with China over Taiwan, expect China to take out our fragile electric system, which they can easily do with a very small nuclear strike. Most Americans could be killed—and Taiwan not saved. The huge forces required for us to assist in Taiwan’s defense drives huge conventional weapons spending requirements that we would not have if we abandoned this suicidal offer to assist Taiwan. If the U.S. withdraws its promises of military support for Taiwan, we should expect China’s nuclear and conventional military build up to slow down, and may find far more cooperation in areas like controlling AI and it’s promise of uncontrollable, unimaginable new Weapons of Mass Destruction (WMD).

## **10. Risking nuclear war by pushing NATO membership to Russia’s border despite Russia’s clear threats of retaliation, prompting war in Ukraine**

Both standing up to China on Taiwan, and pushing NATO to Russia’s borders, stem from vote mongering by career politicians who know that American’s limited knowledge of foreign affairs and national security policy does cover the lesson learned of failed attempts to appease Hitler.

A leading political scientist, Graham Allison, Dean of Harvard’s graduate school of government, concluded that the reason General Douglas MacArthur was able to defy his orders during the Korean War and march too far north bringing China into the war was that Truman and top Democratic politicians were afraid to confront him because of political backlash due to the general’s public popularity.<sup>xxv</sup> When career politicians have to choose between what is best for our security and best for their political party and election success, they prioritize political power.

President Clinton pushed NATO expansion to Russian borders, ignoring advice from Kissinger and other experts and threats from Putin that Russia would not tolerate this, never allow Ukraine (part of the former Soviet Union) to join. Putin is clearly an evil aggressor, but the Russian war with Ukraine is probably due largely to Clinton, Bush 2, and West European politicians pandering for votes by looking tough against Russia and promising Ukraine NATO membership. In 2008 at a senior NATO summit, Ukraine was promised eventual membership in NATO, despite Russia’s assurances they would never allow it.<sup>xxvi</sup>

If Russia overran Ukraine tomorrow, they would pose little threat to NATO and Putin would have little force beyond nuclear weapons (that the UK and France can deter, especially with the U.S. still backing NATO) to threaten Europe.

But with Russians getting killed by U.S. and west European weapon systems, including strikes deep inside Russian territory, we face a big risk of Russian use of nuclear weapons as Putin has threatened, or worse—Russian agents releasing a deadly virus in the U.S. and west Europe to plunge us into a horrible pandemic and end aid to Ukraine.

We have already experienced foreign policy disasters, big loss of American lives, from basing national security policy on domestic vote considerations rather than real national security interests. Far bigger losses from sacrificing sound foreign and defense policy for domestic election votes lie ahead if we do not stop these bad practices.

## **Why is our Government working to kill us?**

There is not a government conspiracy to deliberately kill citizens. But because of lobbyists, career politicians always running for re-election and prioritizing campaign donations and votes, the lack of any Constitutional limits to government spending and policy since President Franklin Roosevelt (FDR) coerced the Supreme Court into abandoning Constitutional limits to government, a new very bad system of government has evolved. The end to Constitutional limits on government has led to massive growth in political power, career politicians, an entrenched, self-serving government bureaucracy, uncountable thousands of new laws and regulations benefiting lawyers. Today any program or regulations with billionaires or an influential interest group behind it can be passed--even when it threatens and takes the lives of the silent majority.

At both the USAF Academy, and then the Kennedy School of Government at Harvard University, I was taught “Allison’s models,” the best explanation of why governments make bad decisions. In *Essence of Decision: Explaining the Cuban Missile Crisis*, political scientist Graham Allison analyzed the 1962 Cuban Missile Crisis to show how government national security decision making is not so much “rational” or good decision-making, but shaped by bureaucratic self-interest and domestic politics, yielding potentially disastrous results.

Model 1, the "Rational Actor" Model, is what we would expect: the government examines the problem and options to solve, and makes the best decision for the country. But rational, good decision-making fails to explain the Cuban Missile Crisis or most government policies and programs. So Allison adds Model 2, the "Organizational Process" Model that explains how governmental bureaucracy limits government actions. Bureaucracies follow standard operating procedures and advocate positions that are best for that organization, not the country. This explains much of what happened in the Cuban Missile Crisis, but still leaves some other irrational, bad decisions unexplained.

Thus Allison added Model 3, the "Bureaucratic Politics" Model. This model takes account of “palace politics,” the preferences of political parties, maneuvers to win votes in elections, which action most benefits the government decision maker’s political power. This explains more of the Cuban Missile crisis decisions and makes Allison’s point that governments do not act rationally to maximize the nation’s benefit. In the case of nuclear conflict, as the Wikipedia summary of



Allison's models explains, "by looking at organizational and political models . . . nations, against what was predicted by the rational viewpoint, could indeed "commit suicide".<sup>xxvii</sup>

If you assume that our government is rational, following Constitutional limits, prioritizing the benefit and lives of it's citizens as it is supposed to, you are wrong on all three counts. There are largely good people in government, but the career politicians and bureaucrats that control the government keep passing new programs and spending to buy votes, driving our country into bankruptcy, dividing the nation, setting us up to be killed. They prioritize their power and benefit, and are perfectly willing to trample citizens' rights and sacrifice our lives.

The perverted decision making in Government today goes way beyond Graham Allison's Models 2 and 3. To understand why our unconstitutional, corrupt Government is working to kill us you need to add Model 4: The "Perverted Triangle."

In public history textbooks, written by taxpayer funded professors, Big Government politicians are the good guys, fighting against evil, greedy businessmen. The "Iron Triangle" is the official political science term for the bad alliance of government bureaucrats, elected career politicians, and special interest group/business lobbyists working together to promote their profits and interests. Big businesses and campaign donations to politicians are indeed often very bad, but there is a far worse alliance that has destroyed good American constitutional government and personal liberty: the "Perverted Triangle" of government bureaucrats, career politicians, and lawyers. The latter two are often the same person—attorneys in legislatures that pass laws and regulations that generate more business and income for fellow lawyers, more laws and regulations and jobs for government bureaucrats, more campaign donations and power for the politicians. And many Perverted Triangle members become lobbyists.

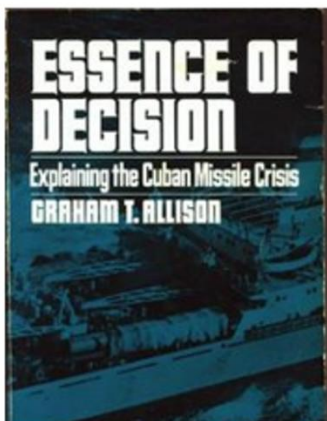

Dr. Allison developed three models of government (and bureaucratic) action, in trying to explain what happened during the Cuban Missile Crisis. Model 4 was developed by Dr. Miller.

Model 1, the "Rational actor" model is the right way to make decisions: analyze the problem, make rational choice of which alternative best meets objectives. This model alone fails to explain what happened during the Cuban Missile Crisis, and likely most major government, bureaucratic decisions.

Model 2, The "Organizational Process" model notes that decision makers do not necessarily seek optimal solutions and are constrained/motivated by the bureaucracy they work with. The bureaucrats follow "standard operating procedures" and decisions are often "satisficing": find a solution that achieves minimum goals restricted by bureaucratic constraints. This explains much of what happened in the Cuban Missile Crisis.

Model 3, "Bureaucratic Politics," explains the rest of the decisions made. "Where you stand depends on where you sit." Those in charge of various state responsibilities argue for their view based on their beliefs and organizational biases. Policy "outcomes" are the result of negotiations among these leaders. "The decisions and actions of governments are essentially intra-national political outcomes: outcomes in the sense that what happens is not chosen as a solution to a problem but rather results from compromise, coalition, competition, and confusion . . . ; political in the sense that the activity from which the outcomes emerge is best characterized as bargaining."

Model 4, the "Perverted Triangle." The "Iron Triangle" is the political science term for the bad alliance of government bureaucrats, elected career politicians, and special interest group/business lobbyists working together to promote their profits and interests. There is a far worse alliance that has destroyed good American constitutional government and personal liberty: the "Perverted Triangle" of government bureaucrats, career politicians, and lawyers. The latter two are often the same person—attorneys in legislatures that pass laws and regulations that generate more business and income for fellow lawyers, more laws and regulations and jobs for government bureaucrats, more campaign donations and power for the politicians. The Perverted Triangle is not a government conspiracy to deliberately kill citizens. ## **12. Funding, promoting AI despite clear evidence that it will lead to more weapons of mass destruction and inevitable misuse to kill millions or all of us**

Artificial Intelligence has raised the likelihood and severity of existing collapse threats and will invent new weapons of mass destruction (WMD). AI is being used to develop new medicines and will be misused by bad people to develop deadly new viruses, easier means to enrich uranium for nuclear weapons, new poisons and novel new ways to kill people we never thought of before. AI, combined with CRISPR and new bioengineering technologies enables small groups and even individuals to design and deliver deadly new viruses and bioweapons that could not only devastate the United States but wipe out most of the human race.

The video below explains how new technologies, irresponsible government, and economic/demographic changes make collapse disasters inevitable. We have entered “The Age of Collapse,” an era where our economy and population is so vulnerable to disruption that law and order vanishes as starving people struggle to survive:

Most experts speaking out on AI threats are warning about the future AGI threat—but there is a far worse, now threat from AI: Bad people using it to develop more effective and brand new weapons of mass destruction. We will very likely suffer a collapse from nation states, terrorists, or individual bad people using AI to design a deadly new virus or new means of enriching uranium for nuclear weapons long before bad AI computers and robots come after us.

Peter Thiel, Palantir’s CEO Karp, other big Tech/AI leaders have Trump’s full support now for a Manhattan Project style AI arms race—but without any of the controls we use with nuclear weapons. Trump just eliminated the Biden Admin’s insufficient regulations/controls on AI—there are none now. You’d have more regulatory hurdles launching a new kid’s cookie oven than selling an AI model that could show you how to use CRISPR to make H5N1 human-to-human transmissible.

AI companies and proponents argue that they are aware of the risks and are working on controls and counter measures. Besides the obvious bias, I find their arguments completely convincing, as explained in this endnote.<sup>xxix</sup>

With the new Stargate project, the problem of bad people misusing AI to develop more powerful and brand new weapons of mass destruction will get worse faster. AI company CEOs are urging an “AI arms race” with China. We are going as fast as we can to improve AI capabilities that will lead to more WMD and possibly human extinction when we should be controlling AI, preparing for its misuse—not treating it like a wonderful new phase of economic advancement.

The need to prevent China from beating us in military uses of AI is correct—but the best way to do this is not an arms race that accelerates uncontrolled development of AI, enabling new weapons of mass destruction that could kill most of us.

## **12. Eliminating battlefield nuclear weapons, endangering troops deployed overseas for domestic political votes**

Another bad national security move to score domestic political points was President George H.W. Bush's unilateral elimination of U.S. battlefield nuclear weapons, a Model 3 and 4 decision, not Model 1 decision-making to maximize the benefit of citizens.

The anti-nuclear movement is a powerful political force. President Bush scored political points by declaring a “peace dividend” after the fall of the Soviet Union, and unilaterally surrendered U.S. battlefield nuclear weapons. Many US politicians, United Nations and NATO officials, proudly insist that any use of nuclear weapons is inherently wrong and evil. The U.S. foolishly, irresponsibly eliminated all its ground-launched short-range tactical nuclear weapons, destroying all short-range ballistic missile warheads and nuclear artillery shells. The Army was left with no way to call in quick battlefield nuclear weapons to stop a heavy enemy ground attack. Aircraft delivered tactical nuclear weapons may not be able to reach the target, and are far too slow in delivering a prompt battlefield nuclear strike whose timing is critical. Russia and China not only kept, but continue to modernize and expand their tactical, battlefield nuclear weapons. The U.S. unilaterally abandoned, destroyed its responsive, short range, low yield battlefield nuclear weapons, disarmed itself. A political peace dividend benefit was achieved for the Bush Administration, but national security was sacrificed. The lack of battlefield nuclear weapons capability invites enemies to use these weapons—especially given western superiority in conventional weaponry.

Nuclear weapons, whether used in prompt global strike to preemptively destroy a WMD attack, or save U.S. military forces from being overrun and destroyed, can be the best or only means to save lives, potentially millions or billions of them—and must stop being condemned as inherently evil or only useful for mutually assured destruction. New technologies in the Age of Collapse will deliver far worse threats than nuclear weapons, and nuclear weapons may be our best means of limiting the loss of lives.

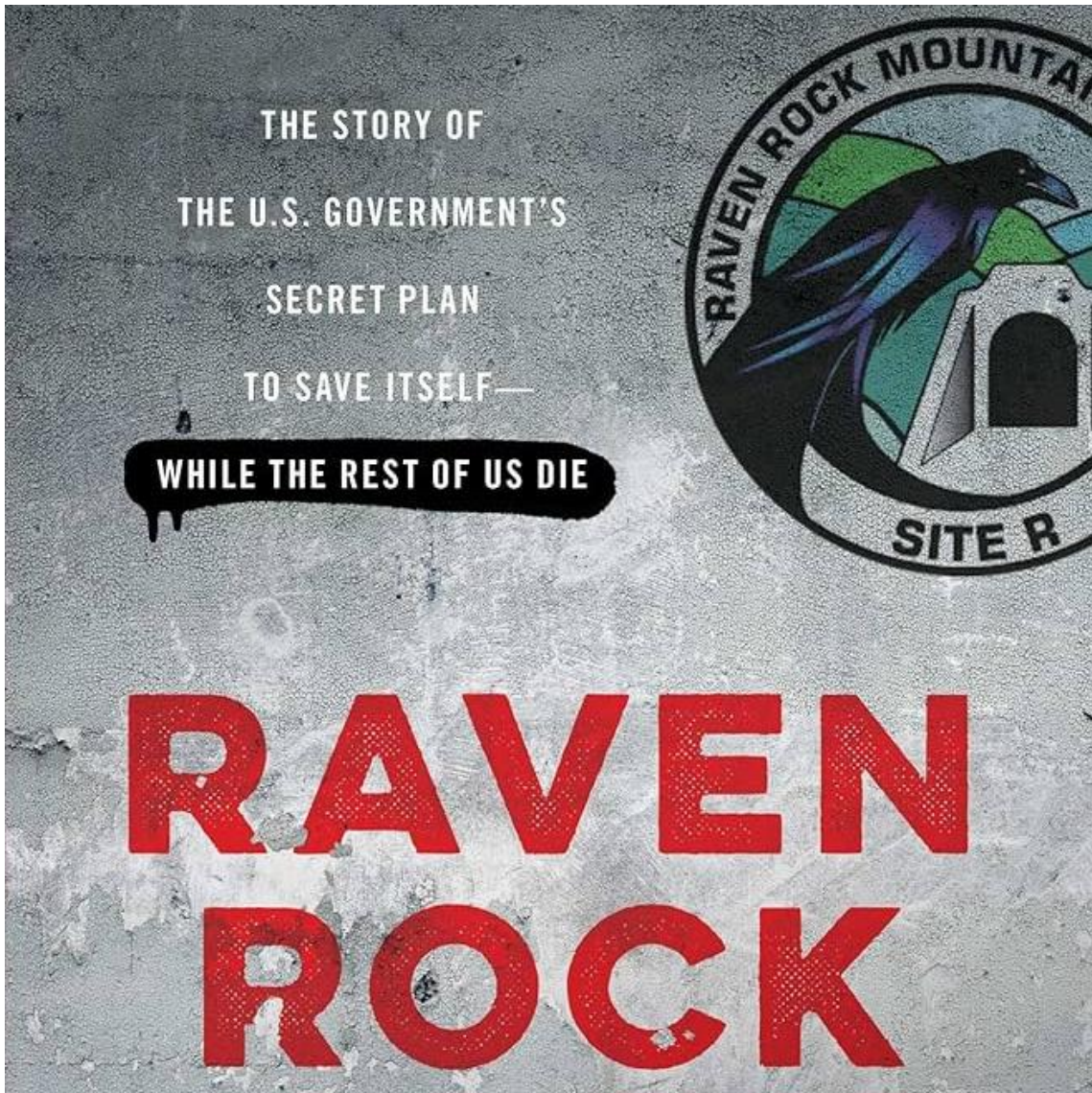
Compared to the uncontrollable, far more deadly risks of Artificial Intelligence, short-range, low yield nuclear weapons with “fail safe” mechanisms are safe. Combined with shallow underground tactical defense shelters for troops (useful only in defense),<sup>xxx</sup> they may be our best means of stopping enemy use of their own nuclear weapons or other WMD that AI invents.

With Chinese defense spending taking off and AI and drones making traditional high tech conventional weapons obsolete, the U.S. no longer can count on enjoying conventional weapons technology superiority. Very few elected officials have any military experience to judge battlefield fighting capability. Low yield, short range, ground launched battlefield nuclear weapons are our best means of deterring and defeating larger enemy armies—or at least preventing our deployed forces from being overrun and killed. But today, U.S. troops are denied their best means of defense since political correctness and votes are the priority of the Perverted Triangle.

### **13. Providing collapse survival protection just for top elected and government officials at Mount Weather and other sites—but no civil defense for citizens**

There are hundreds of federal government survival facilities around the U.S., plus an unknown number of state and local government bunkers. Many hold thousands of people. Not just for the President, Congress and Dept of Defense—every federal agency, even ones you'd consider far from essential or desirable, has facilities, stockpiles, plans to keep their top staff alive. Works of art and historical documents are also covered by Government survival plans. Much of Government Continuity of Government plans remain classified, but professional books like Garrett Graff's,

*Raven Rock: The Story of the U.S. Government's Secret Plan to Save Itself—While the Rest of us Die*, document this 70 year long Continuity of Government survival plan for top politicians and government officials that 95% of Americans know nothing about.<sup>xxx1</sup>



Since 9/11, facilities like Raven Rock in PA have grown dramatically, with 69 buildings in a huge underground city with lakes and fuel storage, its own police and fire departments, and every supply imaginable. Mount Weather in VA for Congress and many government agencies is another massive complex of above and largely below ground buildings, which has also had huge expansion in recent years. There are even “media rooms” at Mount Weather so politicians can reach out to surviving media in their districts—re-election campaigning never ends. Billions are invested in these government survival facilities, hundreds of millions annually just in maintenance expenses.<sup>xxxii</sup>

Every Big Government agency has Continuity of Government and survival plans---even the IRS, Federal Reserve, Post Office, social and welfare program agencies.<sup>xxxiii</sup> The National Archives has three separate survival facilities so they can keep publishing the Federal Register of laws after a collapse.<sup>xxxiv</sup>

U.S. civil defense and Continuity of Government organizations and plans were constantly changed, by ever administration.<sup>xxxv</sup> In addition to funds and plans shifting with domestic political priorities, the leadership of these government organizations are often put in incompetent hands. Like Ambassadors, key officials in not just foreign policy but national security matters, many or most senior government positions go not to the most qualified, but a supporter of the Perverted Triangle.

Michael Brown was an undistinguished lawyer, but had political connections from work with the Republican Party. He left a job supervising horse-show judges to work for George W. Bush's longtime political aide, Joe Allbaugh, who managed Bush's campaign and was rewarded with the top position in FEMA. Brown's closest claim to emergency response experience was a short stint supervising police and fire departments as an assistant city manager in an Oklahoma City suburb. But when Allbaugh left within two years, Brown was rewarded with the top position leading FEMA, and was a key factor in FEMA's disastrously slow, inept response to the long expected hurricane striking New Orleans, Katrina.<sup>xxxvi</sup>

In contrast to the massive Continuity of Government program and shelters for the Perverted Triangle, there is no longer any civil defense program for citizens. The government won't give honest threat warnings to citizen, stockpile any food for them, and certainly won't provide shelters. They will only take care of top elected politicians and government bureaucrats.

Unless you are a top member of the Perverted Triangle, do not approach any Federal Emergency Management Agency (FEMA) facility or military base in a collapse looking for help—you will be shot by government guards using ARs and other “military capable” weapons the Democratic Party seeks to ban for citizens.

#### **14. Abandoning Eisenhower civil defense stockpiled food and exercises for citizens, leaving no preparations for citizens to survive a collapse**

In the 1950s, the Perverted Triangle's power was growing, but with Eisenhower as President, the government still cared for protecting the population and a civil defense program to stockpile food began. Over the 1960s 165,000 tons of food for citizens were stockpiled in 100,000 shelters.

As the Perverted Triangle surged in power in the 1960s and the Republican Party abandoned any pretense of following constitutional limits to government and largely joined the Perverted Triangle, the civil defense program ceased being funded.<sup>xxxvii</sup> In 1969, "it was decided not to renew efforts for Federal stocking when it became obvious that Congress would no longer appropriate funds for shelter supplies."<sup>xxxviii</sup> By 1970 government was abandoning remaining civil defense shelters, dumping the stockpiled food into dumps.<sup>xxxix</sup> The last time the U.S. carried out a national civil defense drill was under the Eisenhower Administration. As the Perverted Triangle took over both parties and most of Government in the 1960s, civil defense programs, food stockpiling, exercises were eliminated.

President Reagan did make some improvements in civil defense programs and started a "Crisis Relocation Plan" to move 150 million Americans out of cities into rural areas, but the plans were not implemented.<sup>xl</sup> In 2009, President Obama signed an Executive Order authorizing the US Post Office, escorted by local law enforcement, to develop capability to deliver antibiotics and medical countermeasures from a Strategic National Stockpile of medical supplies.<sup>xli</sup> How much is in this stockpile is unknown, but who gets priority is not in doubt: top elected and government officials are always the top priority.

Other countries do carry out national civil defense drills.<sup>xlii</sup> Countries like Finland and Switzerland have shelters for citizens, provide weapons for citizens to defend themselves, and have extensive civil defense measures to protect their population. The Soviet Union spent far more on civil defense than the U.S., with a massive program to protect its civilian population.<sup>xliii</sup>

#### **15. Continuity of Government policies will transfer police and military resources to protect top officials and politicians in a collapse—leaving less help for citizens**

There is an absolutely deliberate policy to sacrifice citizens' survival for the benefit of top elected officials. When a disaster occurs, the #1 priority of government is not protecting its citizens. The top priority of government officials is "Continuity of Government"—keeping themselves and their families alive and government functioning. To do this, police and military personnel will be diverted from protecting citizens to providing extra protection for the top members of the Perverted Triangle.

When a bioengineered pandemic starts, the grid goes down, a nuclear exchange occurs, an economic downturn or some political dispute leads to massive unrest or Civil War, or any of the 50+ trigger events Disaster Preparedness<sup>xliv</sup> tracks occurs and yields a collapse, your need for police protection will go way up while their availability goes down because more will be assigned to protect the Perverted Triangle. Look at your Governor next time you see him or her, and notice the security detail always with them. When law and order vanish in a collapse, more police and National Guard troops will be called to duty to ensure the safety of elected officials and their

families. The need for police or national guard protection of hospitals, food stores, and other facilities will also rise in a collapse. If citizens can call for help it will likely be a waste of time. The police and security priority is protecting senior government officials and facilities, not you.

## **16. Executive Orders authorizing Government Agencies to seize food and resources from citizens in a collapse**

Even worse than the Government's massive programs and preparations to protect themselves so they survive while doing nothing to protect citizens (or even warn citizens that they need to get prepared) are the deliberate government plans to "seize assets coast to coast," taking food and other resources from citizens to be controlled and distributed by government.<sup>xlv</sup> As a government official explained, Continuity of Government power is unlimited, "There'll be martial law, and we'll just take it."<sup>xlvi</sup> The Supreme Court, which since 1937 no longer protects the Constitution and citizens' Natural Rights, but backs the Perverted Triangle, has ruled that martial law is justified "to create conditions wherein civil government can be rapidly reconstituted."<sup>xlvii</sup>

Not only does the government stockpile survival food just for the Perverted Triangle but not citizens—Executive Orders allow them to steal food from citizens if they need more! No, this is not a fabricated conspiracy theory, it is found in decades of Executive Orders.

President Kennedy's Executive Order 10998 assigned emergency preparedness functions to the Secretary of Agriculture, including developing plans for the salvage and rehabilitation of food resources. It's not just in Executive Orders, but in federal laws dictating that "In order to prevent hoarding, no person shall accumulate (1) in excess of the reasonable demands of business, personal, or home consumption . . . prevailing market prices, materials which have been designated by the President as scarce materials. . . ."<sup>xlviii</sup>

If you surveyed American citizens and asked them if they think it would be OK for government officials to seize their stockpiled food in an emergency you wouldn't find even 1% who believe this is fine, a good idea. But it is the law, set by the Perverted Triangle for their benefit.

Continuity of Government is not just the policy and top priority of the federal government—it is for State and local governments as well.

***Government agencies are authorized to steal food and resources from citizens in a collapse—their #1 priority is protecting themselves. Citizens are not just expendable, they are exploitable—a resource for Government to raid if their stockpiled supplies run low.***

Many Continuity of Government Executive Orders are classified. But this Google AI Summary concluded that they do indeed authorize government officials the right to seize citizens' property in a collapse: "Executive Order 13603, also known as the National Defense Resources Preparedness Order, was signed by President Barack Obama on March 16, 2012. . . Gives the federal government the authority to seize property, allocate services and facilities, and more."<sup>xlix</sup>



No citizen under today's unlimited government power and a legal system which refuses to enforce Natural Rights could successfully argue in Court or in practice against government officials (backed up by police or military forces) demanding to seize their personal supplies. Backed up by the very clear "Continuity of Government" policies at all levels of government, there is little doubt that many government officials will steal food and supplies from citizens in a collapse if they faced shortages—arguing that COG policies clearly dictate that their survival is the top priority. It is crystal clear that our Government prioritizes their benefit and survival, and is absolutely OK with normal citizens being exploited and killed as necessary to keep them alive.

Having served in Active duty, Reserve and National Guard forces, I'm confident that the majority of military personnel will refuse government offers to steal food from or kill citizens. But government officials have given themselves the authority and ability to kill citizens in a collapse, and some will find police/military forces to support this.

### **17. Laws limiting magazine size and attempts to ban AR-15s and "military capable" weapons that citizens need in a collapse to defend against marauder groups**

If all the government was doing was protecting itself and not doing anything to help citizens survive a collapse that might be acceptable if they would stop trying to make it impossible for us to survive on our own. Trying to ban the weapons we need to defend ourselves in a collapse is another way some parts of the Perverted Triangle (largely the Democratic Party) is actively working to kill us. Most top Democratic career politicians, former President Biden, California Governor Gavin Newsom, have all pledged to ban "assault rifles" (another big government lie--an AR-15 is not an "Assault Rifle," the AR stands for "Armalite" the company).

In a collapse you must have military-capable weapons to survive. If an MS-13 gang is ransacking your neighborhood, with no police available — your double barrel 12-gauge shotgun is useful, but you need far more firepower. The compelling justification for military-capable rifles is not hunting or "normal" self-defense, but survival after a major disaster that leads to a collapse in economic activity and widespread, long-lasting loss of law and order.

U.S. government survival facilities don't just have ARs to keep civilians out in a collapse—they have machine guns and grenade launchers stockpiled in their bunkers.<sup>1</sup>

The 2nd Amendment of the Bill of Rights (all 10 of which were deliberately adopted to add checks on federal government abuse of power) gives no wiggle room for lying lawyers and politicians to limit or control citizens' essential right to have weapons: "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed."

The argument that the Second Amendment's writers intended to restrict individual gun ownership but not gun ownership by militias is nonsense. Farmers in the 1700s (90%+ of the population) and many town, urban dwellers owned rifles and pistols for hunting and self-defense, most not militia members. The motivation for the 2nd Amendment was not just defense, but also offense--the ability to threaten government with force, rebellion, to preserve a "free State" since the biggest perceived threat to freedom in the founding era was a powerful national government that might try to abuse power as the "anti-Federalists" and many Federalists feared. As the Father of the Constitution, James Madison pledged in Federalist #46, citizens bearing arms have the ability to fight tyrannical government and "shake off their yokes," "overturn" tyranny. Armed citizens form "a barrier against

the enterprises of ambition, more insurmountable than any which a simple government of any form can admit of.” Writing to convince people to support the Constitution, not fear federal government abuse of power, Madison’s clear point is that armed citizens and militias are a means to fight and thus deter Big Government abuse of power. Anyone today who argues that Madison would support government bans or control of citizens’ ownership of weapons is delusional or a blatant liar. As a Heritage Institute researcher and writer explained, “The notion that the federal government has the power to impose gun-control laws is an invention of the 20th century, when progressive judges, rather than applying the law as it had always been understood, decided to rubberstamp unconstitutional gun restrictions in the name of public safety.”<sup>li</sup>

If the Perverted Triangle wants to ban ARs they should start by disarming Mount Weather and Raven Rock guards, surrendering ARs, high capacity magazines, other “military capable” weapons.

### **18. Regulations stopping small farms and domestic gardening/ranch animal husbandry vital to collapse survival**

All fifty states have enacted right-to-farm laws that seek to protect qualifying farmers and ranchers from nuisance lawsuits by lawyers, but they often fail and do little to stop government bureaucrats from adding building codes, zoning and regulations that violate Natural Rights to use private property and make small farming difficult or impossible. A chicken coop may only be allowed if it is 150 feet from a house—impossible on small lots, and an unreasonable requirement. Many states have water laws that effectively prevent gardening or keeping a few ranch animals; sometimes even banning you from using the water you collect off your roof. Fees are often imposed to pay for the bureaucratic oversight you don’t want.<sup>lii</sup> Many rural counties don’t want regulations impacting backyard farms, but if the Democratic Party controls the state government (states with a majority of the population in big cities) they often force Big Government regulations on rural counties. Thus you can be in a rural location in California, Nevada, Colorado, Illinois, New York and elsewhere – and face the same building codes and zoning requirements of big city dwellers, eliminating your Natural Rights to use your private property and farm/ranch to produce food to survive a collapse. Urban representatives in a majority pass regulations dictating the square footage requirements for ranch animals: better for your chicken to have more square footage to roam, even if it means you die from starvation.

Farms with less than half an acre in Oregon are harassed by the Oregon Water Resources Department, insisting they cannot irrigate without a permit. As one owner rightly pointed out, “I don’t know why growing food is illegal.” In Oregon, the government claims to own all the water, and citizens must have their approval to use it. Getting an irrigation permit takes over a year, and in Oregon, small farm water permit requests are usually rejected.<sup>liii</sup> This is another state where Big Government run by the Perverted Triangle is promoting regulations, bureaucracy, and legal action to benefit themselves at the expense of citizens’ Natural Rights, including the right to use your private property to grow food and survive a collapse. Natural Rights to privacy, personal property, even self-defense and survival now lost in America where the Perverted Triangle and a perverted legal system where the Natural Rights we fought a Revolution for are no longer recognized.

### **19. Zoning and building regulations that violate our Constitutionally protected Natural Rights to private property and make it difficult or impossible to prepare for collapse**

Americans need to be prepared for a collapse that could last for over a year, but government rules and restrictions make it far more difficult and costly to prepare. Zoning and building codes greatly increase the costs of a building. Limits of one residence on a property mean people can't spread out into separate, smaller buildings to be both safer in a pandemic, and more able to defend a compound from marauders in a collapse. The huge increase in building costs from government permits, regulations and building codes adds tens of thousands of dollars in unnecessary expense.

Even in rural counties, state governments controlled by the Perverted Triangle have banned or limited wood stoves, the most important, often only source of energy for heating and cooking that Americans will have during a collapse. At our Fortitude Ranch locations we have lots of wood stoves because our electric grid is extremely fragile and unlikely to operate in a collapse, and there will be no gas or coal deliveries.

We need to stockpile antibiotics and prescription drugs since there will be little or no production or distribution of drugs in a collapse, most hospitals will be inoperable. But government drug laws make this impossible. You can only get a prescription for an existing condition and short term supply of antibiotics and drugs.

We have thought about putting a fortified, urban-style Fortitude Ranch facility in New York City, the worst place in the country to try and survive a collapse—but their government regulatory barriers and zoning and building code extra costs are too horrendous. The biggest barrier to prepping is Big Government, created by and for the benefit of the Perverted Triangle at the expense of our Natural Rights and our lives.

Overall, the morass of government regulations, more than any person could hope to read in a lifetime, raises the cost of everything, decreasing money available for preparedness, making stockpiled supplies, building more expensive or impossible.

Building codes and regulations for cities are being forced into rural areas in states controlled by the Democratic Party, driving up costs or preventing vital collapse survival preparations. Even in remote deserts in Nevada, putting up a simple building the government regulators who ignore your Constitutionally guaranteed Natural Rights to use private property will require you pay to have a "Professional Engineer" stamp on your plans—adding \$10,000 or more in completely unnecessary costs. There are no neighbors anywhere, no possible argument for public safety protection. But the Perverted Triangle insatiable power grabs require no reason and have no limits.<sup>liv</sup>

The biggest barrier to your survival today is unconstitutional Big Government serving the Perverted Triangle. They are not just failing to protect us from external threats we cannot handle on our own (their proper role) but make it far more difficult or impossible for self-preparedness.

## **20. Government forest and wildfire mismanagement, pleasing environmentalists and promoting government firefighter union pay, preventing volunteer help to stop wildfires and loss of life**

Government mismanagement of forest and wildfires is a long-running government led disaster killing Americans. Citizens killed in recent California wildfires, and forest fires across the west, are dying because elected officials prioritize votes and government union firefighters prioritize more jobs and higher pay over citizen deaths.

“For decades, federal, state and local agencies have prioritized fire suppression over prevention, pouring billions of dollars into hiring and training firefighters, buying and maintaining firefighting equipment and educating the public on fire safety.”<sup>lv</sup>

The government policy of fighting all forest fires was a bad decision for citizens, but great for government firefighting jobs. Native Americans knew that fires were vital to keep the forest open and thin, clearing out dead trees and vegetation. But with the U.S. Forest Service created in 1905, government forest management shifted towards fire suppression. It was fantastic for getting votes—government firefighters protecting citizens by putting out forest fires. But it was a bad policy for the long term, as we have experienced over the past decades.

In addition to needing controlled burns, preventing horrible forest and wildfires requires clear-cut areas for firebreaks. I’ve seen this in Scotland; despite their huge tourist industry and need for having beautiful landscape. But the leading constituent group that lobbies and votes based on government forest management policies are environmental groups. So to pander to them and get their donations and votes, government favors not allowing evil logging companies to clear cut trees for firebreaks. Uninformed citizens also would prefer seeing pristine forests, not hundred and thousand feet wide areas cleared of big vegetation so wildfires can be limited and put out before they become the massive, uncontrollable burns we now are plagued with.

Victor Davis Hanson, a professor emeritus at California State University and Fellow at Stanford University’s Hoover Institution, has condemned California Governor Newsome for not building more dams and reservoirs, and for releasing water to please environmental rather than save water for firefighting.<sup>lvi</sup> State and federal environmental laws, written to pander to environmental groups, prohibit or lead to 3 to 5 year delays in getting forests thinned or preventative burns.<sup>lvii</sup>

In addition to Perverted Triangle policies that prevent or delay clear cutting of trees and controlled burns, prioritizing the jobs and wages of government union firefighters is another major reason for the massive increase in wildfire devastation.

I saw firsthand why fire fighters are failing to stop wildfires. I was driving to Forbes Park on June 27, 2018 when a wildfire next to our development started. By the time I got to the gate to my dismay there were fire fighters there not fighting the fire—but blocking our road. Less than a mile away, easy walking distance, the fire had just started. There was no high wind, it was the ideal time to grab as many people as possible and clear vegetation, prevent the fire from spreading. But the firefighters did not engage the fire—they deployed to block people. They could have sent homeowners associations or police to do this, but a group of uniformed firefighters stood on our road blocking traffic, ignoring the relatively small fire near us, squandering the best chance to stop the forest fire before it grew too large to stop.

This became the Spring Creek wildfire, burning over 100,000 acres, the third largest wildfire in Colorado history. The fire raged for months—not really ever fought by firefighters, burning largely uncontrolled all summer, from June into September.<sup>lviii</sup> Several large developments were near where the fire started, ours had a volunteer fire fighting group. They were not called up, not allowed to assist.

Why? Because the priority of union firefighter management is not preventing fires or protecting citizens, it's maximizing the number of jobs and pay for their union firefighters. So the firefighters top priority is preventing volunteers from helping, not fighting fires. Not volunteers to spray water on fire, but to do the majority of wildfire work—which is digging ditches, removing flammable material far from the fire, building fire breaks.

Over 85% of professional firefighters in the U.S. are unionized.<sup>lix</sup> The most unionized industries by far are public sector jobs. neither federal government employees (25% unionized) or state government employees (29%) come close to firefighters in their devotion to union job and higher pay.<sup>lx</sup> In contrast, private sector industries are 6% unionized.<sup>lxi</sup>

When you've got hundreds, thousands of able-bodied people right there to help dig/cut/clear firebreaks, it is outrageously wrong to abandon this volunteer manpower, especially in the first hours and day of a wildfire when you must stop it quickly before it becomes unstoppable. But government union-controlled fire departments see volunteer help as an enemy of their job opportunities, so they reject volunteer help and devote critical resources, even in the most vital early hours of a fire, to stop people, not fight fires. It is a gross lie to say that this is prioritizing protecting human lives. The large group of homeowners I was with were never in the slightest danger. We could have quickly started clearing vegetation on both sides of the road we were standing on without being in any danger—especially with professional firefighters working with and directing us. But the priority for government unions is not serving citizens or protecting them, but more jobs and higher pay.

What makes this union firefighters priority of stopping us from helping them fight fires particularly galling and outrageous is that most U.S. firefighters are volunteers! Only in the once "land of the free" could government block or outlaw people from fighting fires to protect their homes. A home fire involves risk from falling ceilings and toxic chemicals. But the vast majority of work fighting a wildfire is not dangerous or skilled--it is simple manual labor conducted far from the flames—shoveling more than using saws, clearing away burnable material with your hands, shovels and axes

But

(widely available tools). Any moron can effectively do this work—and people trying to protect their homes and neighbors from wildfires will be particularly motivated, hard working volunteers. With professional, trained firefighters instructing and supervising, volunteers can do very effective safe wildfire fighting work. But government employee unions prioritize their jobs and pay.

The government union priority of protecting their jobs also takes police manpower away from useful emergency response to more violations of Natural Rights. In many jurisdictions (including California) it is a crime to refuse a wildfire evacuation order, and you can be arrested. Police are tasked to arrest and remove citizens exercising their Natural Rights to protect their property (and arguably protect their lives). With bad people coming in to loot areas that are evacuated, there is additional incentive to stay and fight fires. If just 20% of the hundreds of thousands of people evacuated in the recent Los Angeles area fires had been allowed to stay and fight the fire, some would have been put out the first day, others would have been contained far faster, fewer would have died. If some volunteers assisting had died—that would have been because of their decision to volunteer; the kind of decision free people, Americans, should be allowed to make. It is not up to the fire fighter's union management or government officials to decide if people want to volunteer to fight wildfires and protect their property. America fought a Revolution and created the Constitution to protect their Natural Rights to live in freedom, control their private property, defend themselves—not serve as dependents and victims to unlimited government, the Perverted Triangle.

Wildfire fighting in the U.S. must switch to planning for and encouraging volunteers, maximizing volunteer help to halt wildfires sooner. We need to clear cut wide 500', 1,000' wide swaths of public forests to make firebreaks, making it possible to prevent massive wildfires—harvesting a small percent of trees to protect the forest, wildlife, and human houses and lives. Or we can continue current government mismanagement and abuse to maximize wildfires and union firefighter pay.

## **21. Broadcasting messages and sending satellites beyond our galaxy to advertise and map our presence so alien civilizations more advanced than us can find us.**

While there is inconclusive evidence on whether or not we've been visited by aliens from other planets, there is a high likelihood of other intelligence life in our vast universe. For security purposes, we can't assume there is not. Given the estimated 14 billion year age of our universe, the likelihood of a far more advanced civilization out there is probably quite high. The worst assumption to make is that a highly advanced foreign civilization would visit us to help us rather than exploit us (treating us like we treat rats). So for our government to be spending our tax dollars to push signals and send probes into space to advertise our existence and location is dead wrong.

The Perverted Triangle's decision-making is dominated by buying reelection votes and increasing jobs/programs/regulations/government power. So when astronomers and scientists fascinated by the possibility of extraterrestrial life, and government bureaucrats in NASA similarly fascinated and eager for bigger budgets, lobby career politicians for these broadcast our presence to the universe programs, the Perverted Triangle approves it—even though it is not just more tax burden for citizens, but a huge, unnecessary risk that could lead to our enslavement or slaughter.

## **22. Unconstitutional regulations and taxes that crush small businesses, making it harder to escape poverty, homes unaffordable, raising divorce and suicide rates with the economic stress of high taxes costs of unlimited government spending and regulation**

The Perverted Triangle makes running a small business or family farm much harder and less likely to succeed because of outrageous regulations, huge permit and government fees, and a tax code that is impossible to comply with (deliberately so) unless you employ accountants and lawyers. The tax code is many times the length of the *King James Bible*, littered with special provisions that politicians passed as pork benefits to buy votes. It is a huge cost for small businesses and citizens, but profits for our million plus lawyers (many of them voting as elected officials when laws were passed), plus jobs for bureaucrats that enforce rules (and donate, campaign for the politicians).

The Sarbanes-Oxley Act on business financial disclosure is 810 pages long, Obamacare over 1,000 pages, and the Dodd-Frank Wall Street Reform and Consumer Protection Act is 2,300 pages long. A huge company can employ lobbyists to tailor the laws passed for their benefit and afford the overhead staff to comply with all this nonsense. Smaller companies are disadvantaged by this regulatory morass, and every citizen losses with the added costs for products and services. The Perverted Triangle is the beneficiary, citizens are the losers.

The tax code is not a system designed to efficiently provide revenue for Government, it is a cancerous perversion shaped over decades in lobbying, buying votes, and creating jobs and wealth for the Perverted Triangle.<sup>lxii</sup>

A leading cause of marital strife and divorce is stress from inadequate money.<sup>lxiii</sup> While it is extremely difficult to estimate, you can be confident that the financial loss of taxes generates divorce, stress, crime, unhappiness, and kills people. An American Enterprise Institute report, drawing on a variety of studies, estimates 1 death for every \$10 million in lost income from government programs that take your tax dollars, reduce your earnings ability, and cut economic growth and productivity. His estimate back in 2012 was 140,000 deaths annually from the direct and unintended consequences of government spending and regulatory reductions in income and productivity.<sup>lxiv</sup> With much higher government spending today, the annual deaths from lower incomes and loss of productivity due to government programs and regulations are much higher.

## **23. Overspending and driving national debt to a level that will bankrupt the country and lead to an economic collapse**


It is not just the rise in federal government spending as a percentage of GDP, from less than 5% a century ago to 30% today; but the mix of that spending that is grossly wrong. Defense spending as a percent of GDP has fallen from 10% in peacetime in the 1950s to about 3% today, now matched by spending on interest on the cancerous national debt the Perverted Triangle has built up. Spending on social welfare programs is a staggering 20% of GDP. And this does not count the huge state and local government spending and debt. Government debt is larger than, about 125% of our GDP! In 2024, for the first time, the uUS reached the point where we are spending more on our national debt than we are on defense spending!<sup>lxv</sup>

There is no honesty in federal government budgets or accounting, but we roughly know that from the first year Medicare spending was visible on the books, in 1967, through 2020, Medicare and Medicaid combined cost about \$18 trillion—about the same amount as federal deficits over that

same period.<sup>lxvi</sup> As of December 2024, the reported uUS debt is over \$36 trillion, spiraling up every minute! The only way to grasp the magnitude of this debt is to put it in per capita terms. Every American owes over \$100,000 in government debt!! But since most people don't pay taxes (too young or too poor), the debt per taxpayer is over \$260,000. With the average family having just \$11,000 in savings, there is no way we can pay this debt.

Worse, the real government debt is several times more than \$36 trillion! The money owed for Social Security and Medicare and public employee pensions and retirement health benefits are also debts that we as individuals and businesses would have to report, but the cheating, dishonest government does not. The uUS is over \$100 trillion in debt thanks to the Perverted Triangle. The interest payments on our debt are now also in the trillions; the country has amassed debts we cannot repay. Eventually we will have to default on government bonds, Social Security and Medicare benefits promised, government worker retirement benefits, and all the other Ponzi Schemes the Perverted Triangle has passed to amass power. The Perverted Triangle and Big Government have ruined and bankrupted our country. Future generations especially are screwed—but they can't vote, so the Perverted Triangle does not care.<sup>lxvii</sup>

Many state governments, especially those ruled by the Democratic Party, also lie. Last year 27 states could not meet their financial obligations, were in debt. According to “Truth in Accounting,” run by CPAs and Government Accountants, including the former Director of the Government Accountability Office, even states with laws mandating a balanced budget, state spending exceeds revenues, so elected officials (leaders of the Perverted Triangle) excluded costs from their budget calculations, such as future pension obligations or deferred maintenance.<sup>lxviii</sup> The five biggest debtor states were California, Massachusetts, Illinois, New Jersey, and Connecticut—all states dominated by the Democratic Party. New Jersey occasionally elects a GOP Governor, but Democrats have controlled both houses of the legislature, which controls spending, since 2004. The top 5 budget surplus states were all GOP dominated: North Dakota, Alaska, Wyoming, Utah and Tennessee.<sup>lxix</sup>

Another indicator of the destructive power of the Perverted Triangle is the U.S. debt—already well beyond what we can repay and still growing. While the Republicans are almost as bad as Democrats in trashing the Constitution and Natural Rights, pandering and buying votes to reelect career politicians, the fate of Perverted Triangle controlled government is most clear in states run by the Democratic Party. In Illinois, the last time the GOP controlled the Governor's Office and both branches of legislature was 1996 (they also irresponsibly overspend and buy votes, just at a slightly lower rate). Taxpayers in Illinois have \$52,600 in state government debt, mostly for government worker pensions and retiree health care.<sup>lxx</sup> Add this to federal government debt per taxpayer of \$260,000 and it's easier to understand how the Perverted Triangle has effectively corrupted, bankrupted and ruined the United States. If you live in a big U.S. city, the Democratic Party likely



rules and your debt is thus worse. If you are a Chicago taxpayer, add \$20,000 to your government imposed debt load, bringing your total government debt to at least \$335,000.<sup>lxxi</sup>

Truth in Accounting, which added up all government debts, estimated that taxpayers owe \$980,000, thanks to unlimited, unconstitutional, perverted government power.<sup>lxxii</sup> There is no way this can be paid off. Inflation is one result, but with the BRICS movement or other countries upset with U.S. tariff threats and toxic U.S. debt levels, most nations could decide to abandon the dollar for trade settlements and as a reserve currency, leading to a plunge in the value of the U.S. dollar and the worst economic collapse/depression the country has experienced.<sup>lxxiii</sup>

The \$2 trillion in budget cuts DOGE and Trump Administration are working is vital, though few expect success. A paper with some recommendations on how to cut \$2 trillion and also improve national security and citizens' ability to survive in the Age of Collapse is at the link below:

The severe recession or depression that results from our massive debt will yield hundreds of thousands of deaths from the loss of income, the estimated 1 death for every \$10 million in lost income cited earlier.<sup>lxxiv</sup> In our divided, angry, dependent society today, a severe economic downturn could lead to massive violence and a collapse—widespread loss of law and order, societal breakdown that could trigger massive looting and marauding, and millions of deaths.

#### **24. Promoting unconstitutional, divisive social programs that benefit the Perverted Triangle but divide the nation and threaten civil war**

Federal welfare and income redistribution programs are all unconstitutional, not mentioned, unenumerated, or written in the Constitution. The taking of one person's money to give to another against their will is a clear violation of both the 10th Amendment and Natural Rights of private property. American voters have not amended the Constitution to abandon their Natural Rights and authorize government at any level to take money from some citizens and give it to others.

The biggest, root problem with the federal government today, that corrupts and divides our society, is that limits to government programs and taxation are ignored; enabling divisive, expensive, unconstitutional, social programs and regulations to proliferate—bankrupting and dividing the country, eliminating Natural Rights, subverting individual responsibility, and destroying families as government welfare programs replace family care and responsibility.<sup>lxxv</sup>

There is no limit to what unconstitutional government can do to Americans today with our Natural and Constitutional Rights illegally erased, as the traitor/criminal/prisoner Bradley Manning's government-funded sex change operation proved.<sup>lxxvi</sup>

The country narrowly dodged civil war in Nov 2024 with the nation so sharply divided, largely over unconstitutional social and welfare programs. If Trump had lost a close race, many expected massive violence and civil war.<sup>lxxvii</sup> The nation is continuing to divide with Trump in power, and we must expect that some controversial event could trigger domestic violence that may escalate into looting and a collapse with heavy fatalities.

## **25. Hiring millions of government social and welfare workers while not enough police or Army National Guard members for peacetime security or collapse recovery operations**

While there are 23 million government employees (not including military personnel), less than 1 million are law enforcement officers. The Perverted Triangle favors bureaucrats and regulators, not security, the #1 purpose of government. Career politicians can buy more votes with welfare and entitlement payments than funding more police protection.

The misconduct of a very few policemen led to an asinine “defund the Police” movement that sprouted in some big cities, with attacks on policemen that contributed to thousands of law enforcement officers quitting or retiring early--resignation rate in 2020-21 increased 18% and the retirement rate rose 45%. As one Mayor explained, “The toxic national dialogue that demonizes police officers has made police department staffing significantly more difficult for every major city in America.”<sup>lxxviii</sup>

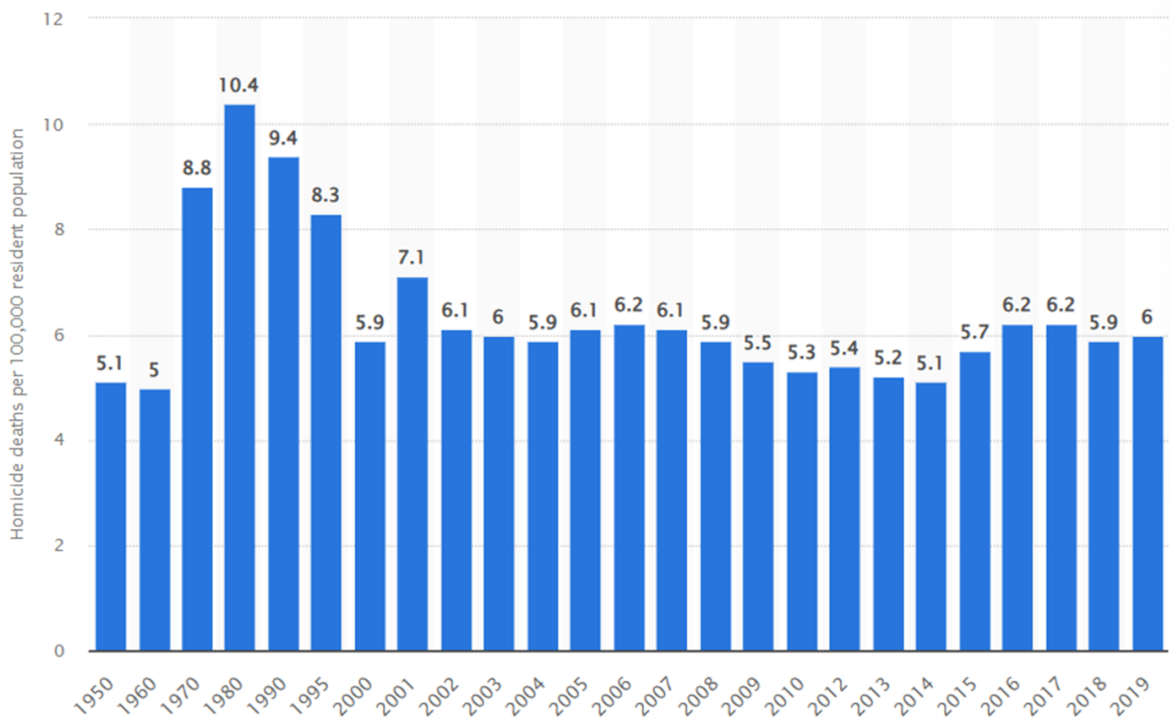
The military and law enforcement personnel are the most valuable and proper government expenditures we make. With the increasing likelihood of homeland attacks and collapse, we need more Law Enforcement and National Guard forces—which we could readily afford by firing millions of government social workers, planning and zoning officials, and regulators, eliminating their programs that violate the Constitution and our Natural Rights.

Over past decades about 20,000 Americans have been killed annually by murder or manslaughter (unlawful killing without premeditated intent to kill).<sup>lxxix</sup> With more law enforcement officers fewer Americans would have died. In the Age of Collapse we must have both a much larger Army National Guard and a huge law enforcement officer reserve force to stop marauder groups and conduct homeland recovery operations. The purpose of government is to protect citizens from severe threats they cannot handle on their own—not to dictate and spend on personal matters, economic and social issues.

## **26. Undermining marriage and families, promoting a subservient, irresponsible populace with unconstitutional government social programs and entitlements that lead to crime, divorce, long-term poverty and dependence, and a higher domestic homicide death rate**

Despite the explosion in social programs, welfare programs and entitlements in the 1960s, crime rates and homicide death rates in the U.S. not only did not improve—they got worse.

Unconstitutional Big Government social programs encouraged divorce, single parents, and subverted families and marriage. The result is more crime and deaths for citizens.

When the government provides welfare payments and services, you don't need a family, or a two-parent family. But family breakdown fuels poverty. Even high school dropouts who are married have a far lower poverty rate than single parents with several years of college. Boys raised without their father are much more likely to use drugs, engage in violent criminal behavior, go to jail, and drop out of school. Girls are more likely to engage in early sexual activity or have a child out of wedlock. The Perverted Triangle blames their failures on other societal or capitalist problems they must solve, like dangerous neighborhoods or poor schools. But they are wrong--family structure and family & individual responsibility are decisive in driving work ethic, good character, and wise decisions.<sup>lxxx</sup>

Since the explosion in unconstitutional welfare and entitlement programs in the 1960s, the percentage of U.S. children living with a single parent has been rising, accompanied by a decline in marriage rates and a rise in births outside of marriage. A Pew Research Center study of 130 countries and territories shows that the U.S. has the world's highest rate of children living in single-parent households. Almost a quarter of U.S. children under the age of 18 live with one parent and no other adults (23%), more than three times the rate of children around the world who do so (7%).<sup>lxxxii</sup> A 10% rise in children living in single-parent homes leads to a 17% increase in juvenile crime. Even in high-crime inner-city neighborhoods, over 90% of children from safe, stable homes do not become delinquents, while only 10% of children from unsafe, unstable homes in these neighborhoods avoid crime. A two-parent family with a father is critical to raise children well and decrease the likelihood of a life of crime.<sup>lxxxiii</sup> The Perverted Triangle's social programs have been

great for political power, government jobs and lawyers income—horrible for citizens, raising crime and murder rates.

## **27. Regulations on food and drugs that violate the Constitution and Natural Rights, misleading people into using unhealthy drugs and foods that benefit special interest and big companies at the expense of health and lifespan**

Because Americans have become so buried in government regulations, subservient to government direction and control, individual and family responsibility for decision making on food, drugs and personal health has been undermined. With Big Government regulating everything, replacing individual liberty and decision-making, citizens assume that the rules and government directions will keep them safe, no need for their judgment or responsibility. You assume that the highly regulated food that manages to get through the regulatory morass must be good for you, and the highly regulated, tested, approved drugs must be safe.

The Perverted Triangles promotion of personal irresponsibility, destruction of families, and unconstitutional regulation of every aspect of personal life and conduct, down to what you eat is a major cause of the estimated 678,000 American deaths annually from irresponsible, bad eating decisions that generate obesity, diabetes, heart disease, and cancer.<sup>lxxxiii</sup> Add drug overdose deaths to this, a number going up, not down, despite the increasing Government control of every aspect of drug development and approval, sales, and healthcare. Purdue Pharma followed the rules and got regulatory approval that helped them push oxycontin, killing 450,000 trusting Americans.<sup>lxxxiv</sup>

## **28. Murderers and criminals freed by legal system corrupted by the Perverted Triangle to maximize profit for lawyers; lawyers allowed to lie in Court, no priority for truth, Natural Rights, or Justice**

Murders and criminals often can go free since the U.S. legal system has also been corrupted by the Perverted Triangle, with lawyers allowed to lie in Court, justice subordinated to lawyer's interests and case precedents, no priority for truth, Natural Rights, or Justice

If more laws and government spending were going to solve crime, it would have ended decades ago. Big Government has failed in its War on Poverty and War on Drugs, and is never going to stop bad people from committing crimes. Gangs and flash mobs can openly shoplift from stores today with employees barred from trying to stop them (too much risk of a shyster lawyer lawsuit), little prospect of being arrested or punished in court. In Big Government states like California where the Perverted Triangle has undisputed control, stealing merchandise worth under \$950 is now judged a misdemeanor, not worth arresting or prosecuting, "shoplifting is now de facto legal."<sup>lxxxv</sup>

The U.S. has the highest liability costs as a percentage of GDP of the advanced industrialized countries, with liability costs about three times the average level of European countries.<sup>lxxxvi</sup>

Because of the Perverted Triangle, the U.S. is plagued with one of the highest rates of lawyers per capita in the world, more imprisoned people per capita than any other country, and an obscenely expensive and ineffective legal system, that prioritizes lawyers and their income, not justice or the Natural Rights we fought a Revolution to obtain.<sup>lxxxvii</sup> Lawyers' costs are obscenely high, and courts encourage or require use of lawyers. Most citizens cannot afford expensive defense counsels, and enter guilty pleas without interviewing any prosecution witnesses—it is cheaper to plead guilty than risk an expensive legal battle where innocence and guilt is subordinated to lawyers income,

case citations and loopholes, and the lawyer-enriching process that allows wealthy parties to endlessly delay and pile on legal costs to bury a poorer opponent. Laws written and passed by lawyer politicians (the Perverted Triangle) bar non-lawyers from giving legal advice—forcing citizens to get abused and fleeced by attorneys. Americans are abused by the Perverted Triangle’s new legal system, with personal liberties and Natural Rights erased, lawyers über alles. We are no longer the land of the free.

The best book explaining how we failed the U.S. Constitution and let politicians, lawyers and bureaucrats screw us, is Charles Murray’s *By the People: Rebuilding Liberty Without Permission*. His summary is accurate and depressing: “The founder’s Constitution has been discarded. . . . Aspects of America’s legal system have become lawless, . . . Congress and the administrative state have become systemically corrupt, for reasons that are inextricably embedded in the market for government favors.”<sup>lxxxviii</sup> The Perverted Triangle has produced a deluge of thousands of laws, an uncountable number of regulations, written to promote more government bureaucrats and regulation, more income for lawyers.<sup>lxxxix</sup>

Washington D.C. is full of lawyers who got elected to Congress, passed laws to generate regulations and business for law firms, then left political office to serve as lobbyists helping clients pass more laws and regulations to benefit their cause.

Philip Howard has long campaigned to try and fix our horrible legal system, with books and reform policies laid out in *The Death of Common Sense* and *The Collapse of the Common Good*. Howard explains how “A culture of legal fear is not what our founders had in mind when they created the legal framework for a free society. Law is supposed to support free choice, not impede choices all day long.”<sup>xc</sup>

As a result of Perverted Triangle promotion of laws, regulations and business for lawyers, the U.S. ranks at the top of countries with the highest per capita rate of imprisonment. The U.S. has just 4 % of the world’s population but locks up 25% of the world’s prisoners.

The nation founded as the land of the free, the champion of liberty has been corrupted and perverted into a land of government and lawyer theft and abuse. America is no longer the land of the free.

The Perverted Triangle has turned the United States into the biggest police state<sup>xcv</sup> in the world. Big arrest rates, court loads, and prison populations mean huge job opportunities and profits for lawyers, more government jobs. The average per-inmate cost of incarceration in the U.S. is over \$31,000 per year.<sup>xcvii</sup> Prisons cost almost \$100 billion annually, Courts cost over \$60 billion annually, a tax burden of \$1,000 per taxpayer annually.<sup>xcviii</sup> The lawyers are the ones who really make the most money from the unlimited regulatory power of the U.S. Government, with a median salary of \$150,000.<sup>xcix</sup>

With Big Government and our perverted legal system, you can be imprisoned for failing to obey an arbitrary government regulation you may never have heard of or even understand if you read it, violating your retained Natural Right to be left alone with unconstitutional, statutory, legislative laws promoted by lobbyists for their benefit, passed by politicians who accepted their campaign donations, and written by lawyers to generate legal work for their profit. The regulations on latching devices for storage bins in bakeries, how to run your workplace, are hundreds of pages long. Charles Murray is right: “Punishment for failure to observe an arbitrary and capricious regulation is indistinguishable from punishment for failing to obey the arbitrary and capricious demands of an absolute ruler. It is a form of lawlessness.”<sup>xcv</sup> Our Founding Fathers understood that there can’t be too many laws if we want to have liberty and pursue happiness. James Madison in Federalist #62: “It will be of little avail to the people, that the laws are made by men of their own choice, if the laws be so voluminous that they cannot be read, or so incoherent that they cannot be understood . . .” We are long past the point of too many incoherent, un-understandable laws. Light years beyond the level of government abuse that led Colonial Americans to revolt against the British.

So how many Americans are killed by our unjust, corrupt, perverted legal system? Like death from taxes, that is extremely uncertain and difficult to assess, but there are some reasonable estimates.

First, the costs imposed by too many laws and regulations that can land you in court, then forced to use expensive attorneys, is a financial loss that, like taxes, leads to financial losses-stress-deaths (estimated at 1 death per \$10 million in lost income).

With the explosion in regulations and laws that the Perverted Triangle has sold for votes, government jobs and lawyers’ work/income, you can get a felony arrest record for violating a law you’ve never heard of, even minor and unintentional offenses like exceeding a weight limit on a truck or failing to comply with complex regulatory requirements.<sup>xcvi</sup>

Charles Murray from the American Enterprise Institute rightly argues that we have no legitimate or just rule of law: “When the legal process is more costly than you can afford, it is indistinguishable from lawlessness. . . . When defending yourself against a wrongful allegation is not financially feasible, in what sense are you protected by the rule of law?”<sup>xcvii</sup> It is impossible for an average person to even know the laws. Ignorance of the law is no defense in court, but with thousands of laws, many hundreds of pages long, there is no feasible way to comply and avoid getting abused by the Perverted Triangle and our unjust legal system run by lawyers for the benefit of lawyers. There are so many laws, including ones repealing or modifying old ones, that we have no idea how many laws there are. The Justice Department has tried several times to count them and failed.<sup>xcviii</sup> There are over 3,000 criminal offenses, and many more civil offenses you could unknowingly commit in an estimated 23,000 pages of just federal laws. Add to this state and local government laws, every citizen is likely violating laws every day.<sup>xcix</sup>

An estimated 70 million to 100 million Americans have an arrest record, “a direct consequence of decades of mass incarceration and overcriminalization” according to a Center for American Progress study. As a result, half of U.S. children now have at least one parent with a criminal record. Researchers at the Brennan Center for Justice found that arrested Americans see their subsequent earnings reduced by an average of 52%. The study found “an alarming rise in fines, fees, and other criminal legal debts that can total thousands or even tens of thousands of dollars, diminishing families’ ability to save for the future and protect against financial shocks and uncertainty. Beyond the immediate effects of a conviction for the thousands of laws the Perverted Triangle has passed, incarceration puts the family in debt and the criminal record means less chance of loans to start a business, bans from the now up to 1 in 4 jobs that require an occupational license (another result of the self-serving, government and laws promoting the Perverted Triangle) and a host of other collateral damage.”<sup>c</sup>

The legal system is so expensive and unjust, millions of likely innocent Americans take plea deals to avoid more losses and legal system abuse. What do you do when you are innocent, and the corruption of the legal system or wealth of your opponent and their ability to buy expensive lawyers and screw you over in Court leads to loss? The financial loss leads to deaths. I cannot find any estimates of how many people commit suicide as a result of abuse in Courts that prioritize lawyer’s income rather than justice, but there are likely hundreds to thousands annually.

Our legal system has been ruined by the Perverted Triangle, with thousands of laws, millions of regulations, enriching lawyers who are allowed to lie in Court, with rules requiring use of expensive lawyers and banning others from offering legal advice. Worse, Judges (former lawyers), ignore our retained Natural Rights and the 9th Amendment, favoring past case citations at the expense of truth, justice, and our Constitution. Victory in court depends on how much you can spend on attorneys rather than what is just, with Natural Rights not even considered.

With Big Government and our perverted legal system, you can be fined or imprisoned for failing to obey an arbitrary government regulation you may never have heard of or even understand if you read it, violating your retained Natural Right to be left alone with unconstitutional, statutory, legislative laws promoted by lobbyists for their benefit, passed by politicians who accepted their campaign donations, and written by lawyers to generate legal work for their profit.

Most Americans do not know that lawyers in the U.S. are allowed by Judges (former lawyers) to knowingly lie in court. “In France, evidence is not concealed and lawyers are not allowed to use artful lies to pollute the truth. The innocent are rarely charged; 95 percent of guilty defendants are convicted. Public confidence in the system is high.” But in our Anglo-American common law system, “lawyers are encouraged to obfuscate the truth and use sophistry to besmirch the integrity of honest witnesses.”<sup>ci</sup> Justice and strict adherence to the truth are irrelevant in America’s perverted legal system, where expensive lawyers citing dueling old case citations dominates. Justice, what is “right,” is largely irrelevant to the decision and outcome in U.S. Courts today. Former NY Governor Andrew Cuomo complained that “The trial lawyers are the single most powerful political force in Albany.”<sup>cii</sup> The Perverted Triangle has not just ruined American Government, but our legal system too. At the USAF Academy and as an Officer I lived by an honor code that politicians and lawyers violate daily.<sup>ciii</sup>

Some lawyers recently used the AI tool ChatGPT to argue non-existent judicial opinions with fake case citations, and “continued to stand by the fake opinions after judicial orders called their existence into question.”<sup>civ</sup> The lawyers were not disbarred for inventing false evidence and lying,

just issued a small \$5,000 fine so still able to generate a big profit on their losing case. In our lawyer-run legal system, with non-lawyers banned from providing legal advice and citizens often required to use lawyers, the courts serve lawyers, not justice, not citizens. The losers in the Perverted Triangle controlled legal system are citizens' Natural Rights, our money, our private property, and our lives.

## **29. Unconstitutional, ineffective “War on Drugs” that does not stop drugs but yields higher crime and murder rates for Americans**

A great example of how our laws and Government are killing Americans is the four decade long-running “War on Drugs” failure.

About 20% of jailed Americans admit to committing their crime to get money for drugs.<sup>cv</sup> Because drugs are illegal, not able to be produced and sold cheaply, their price is orders of magnitude higher, driving addicts to robbery to fund their bad habits. Thousands of Americans are killed in robberies yearly—and many can thank our Government's War on Drugs for their deaths.

Countless studies have shown that criminalizing drugs yields higher prices, more gang and criminal profits and activity, more thefts to afford the higher cost of drugs from the Black Market and damage to innocent, non-drug using citizens.<sup>cvi</sup> Yet the government publishes formal reports saying just the opposite, that “Drug-related crimes may decrease with legalization but other crimes, especially violent crimes, may increase.”<sup>cvi</sup> We cannot trust a government report to be honest; serving the Perverted Triangle is the top priority of government employees, even when the policy is killing Americans, not helping them.

Drug laws are a financial windfall for lawyers and Government/Court jobs, but a deadly disaster for American citizens.

A failure from the start, Nixon's War on Drugs continued under all Presidents and remains our idiotic, unconstitutional policy today—though most states have rightly nullified some aspects of it. It is a failure in reducing illicit drug use (which is much higher now), and more Americans are dying of overdoses than any point in modern history--plus deaths from the crime generated to pay for expensive drugs killing totally innocent citizens.

Our ongoing war on drugs is so bad, even the United Nation condemns and ridicules the stupidity and disastrous results. How in the world could the nation that championed liberty and freedom have the highest per capita rates of incarceration in the world??!! It's quite simple—the Perverted Triangle and Big Government benefit from this war. Lawyers love the huge business defending and prosecuting the millions of Americans accused of or jailed for doing something they have a Constitutional right to do. The Perverted Triangle wins, citizens lose.

Quoting an American Civil Liberties Union staff member, “A significant part of drug enforcement efforts have shifted from prosecuting drug crime to seizing property; indeed, by the late 1990s, many drug enforcement agencies were taking in more money from asset forfeiture than they received from their budgets. Self-financed police groups need not justify their activities through any regular budgetary process, and accordingly, such groups have constructed a veil of secrecy, thus enjoying freedom from legislative oversight and setting an agenda accountable to no one.”<sup>cvi</sup> Jobs, patronage, money, uncontrolled power—no way the Perverted Triangle will give this up. We need a war on the Perverted Triangle to stop the war on drugs.



And what a simple problem to solve: The 10th Amendment is crystal clear in wording and legislative intent: the federal government may not pass any laws or act on any issue unless it is “enumerated”--specifically written out in the Constitution. The federal government has no enumerated power, no right to force Americans to not use a drug, cigarette, drink or food. The Constitution grants us the solution to end the Perverted Triangle’s War on Drug spending boondoggle and crime disaster with any one of three means—declare it unconstitutional (Supreme Court), nullify it (State Legislatures), or refuse it (American citizens). If some idiot wants to use addictive, damaging drugs we can’t stop them and have no right to. If Big Government does not interfere, a market for their drug will provide it at the lowest possible price, reducing likelihood of being robbed by an addict or the gangs that illegal/high cost drugs support, and we will avoid the tax bill of a Perverted Triangle anti-drug program and the deaths from taxes.

The War on Drugs is also proof that the Supreme Court’s obscenity in the 10937 Helvering decision, which erased the 10th Amendment, was absolutely wrong and illegal. The Supreme Court is to interpret the Constitution, they cannot amend or ignore it, and there is absolutely no doubt about the crystal clear limit to federal power the 10<sup>th</sup> Amendment provides. When the federal government outlawed alcohol they had to pass a Constitutional Amendment to do it because the Constitution does not mention

and thus does not allow such federal policies. Then another Amendment was passed, repealing Prohibition after its miserable failure. What changed in the Constitution to make it constitutional to ban drugs, but not alcohol? Nothing. What changed was the Supreme Court, threatened by FDR, decided to ignore and erase the 9th and 10th Amendments, and then joined the Perverted Triangle.

# The Drug War, Mass Incarceration and Race

With less than 5 percent of the world’s population but nearly 25 percent of its incarcerated population<sup>1</sup>, the United States imprisons more people than any other nation in the world – largely due to the war on drugs. Misguided drug laws and harsh sentencing requirements have produced profoundly unequal outcomes for people of color. Although rates of drug use and sales are similar across racial and ethnic lines, Black and Latino people are far more likely to be criminalized than white people.<sup>2</sup>

## The Drug War Drives Mass Incarceration and Racial Disparities in U.S. Judicial Systems

There were more than 1.5 million drug arrests in the U.S. in 2013. The vast majority – more than 80 percent – were for possession *only*.<sup>4</sup> At year-end 2012, 16 percent of all people in state prison were incarcerated for a drug law violation – of whom nearly 50,000 were incarcerated for possession alone.<sup>5</sup> More than 50 percent of people in federal prisons are incarcerated for drug law violations. About 500,000

In 2010, Federal Reserve Chair Ben Bernanke defined a “Too-big-to-fail” firm as “one whose size, complexity, interconnectedness, and critical functions are such that, should the firm go unexpectedly into liquidation, the rest of the financial system and the economy would face severe adverse consequences.”<sup>cix</sup> This was the excuse for government support, loans, bailouts that went to the biggest, wealthiest banks, owned by and paying salaries to millionaires and billionaires. The Federal Reserve is supposed to be an independent arm of Government, but it is effectively owned and controlled by Wall Street, a tool for the biggest banks and wealthiest Americans who partner with the Perverted Triangle.

The largest companies and monopolies can shape the regulations, and afford the costs of compliance with regulations. Small companies and poor people trying to start a business can’t shape the regulations, and can’t afford the huge costs of compliance (both the direct and the larger indirect costs of staff and efforts to comply).

It is not just lobbying power, but insider access that firms like Goldman Sachs can exploit. The revolving door between the big banks and Perverted Triangle is one obvious means of both influencing the Perverted Triangle and gaining inside information that can be extremely valuable to a private sector firm. Since FDR, in every Administration, Goldman Sachs executives have jumped in and out of senior government positions, back and forth, with clear conflicts of interest from the point of view of citizens, but obviously valuable to the firm paying them.<sup>cx</sup> They also send mid level executives into privileged positions inside the government. It is not just in the Treasury and financial agencies of government. I often saw Goldman Sachs executives working in the Pentagon in a special status. Not really government employees, and supposedly volunteering to help—without any relevant or valuable expertise I could ever discern, but working in some senior, privileged positions, with salaries far above government pay.

With the power of the biggest companies and banks, and big donations to career politicians, rich Americans can avoid getting killed by the Perverted Triangle.

Billionaires can’t get into Mount Weather or Raven Rock—but they can build their own survival facilities, or buy million dollar “Survival Condos.” But the vast majority of citizens are killed by Perverted Triangle programs on a daily basis and will be left to die in a collapse.

### **30. Top elected officials allowed to leak classified documents, undermine our intelligence capability and reduce national security**

Our past two Presidents and other senior politicians have broken multiple laws designed to protect classified information, vital to national security.

I was an intelligence officer in the Air Force, and then worked in the Department of Defense and with the top DoD think tank, with top secret, codeword clearances. If I had done just one percent of the violations of intelligence information handling that Joe Biden, Hillary Clinton, and Donald Trump did, my career would have been ruined and I would have been severely punished, serving jail time. What these two Presidents and Secretary of State did was absolutely wrong, dangerous for national security, and deadly for human intelligence assets. Hillary Clinton’s illegal private email server contained information that was classified at a higher level than “Top Secret,” with special access program information. Top Secret means, information whose unauthorized disclosure could result in exceptionally grave danger to the nation. Top politicians get away with leaking classified

information or breaking laws, special treatment, not punished for violating laws, not held accountable for their crimes.<sup>cxix</sup>

Congressmen have get out of jail free cards enabling them to release classified information for personal political benefit. Their overriding objective is media coverage for more re-election votes, so they are tempted to release classified secrets, and often do so. In 2001 President George H.W. Bush complained of Congressmen leaking classified information that put U.S. troops at risk. But no action was taken. Like so many laws, they are not enforced against top members of the Perverted Triangle. Citizens are jailed for disclosing classified information and jeopardizing national security—elected officials can break the law and sacrifice our lives with no penalty.<sup>cxii</sup>

## **How can we fix our horrible, deadly, unconstitutional Government and save ourselves?**

As Thomas Paine wrote in *Common Sense* in 1776, “Society in every state is a blessing, but Government, even in its best state, is but a necessary evil; in its worst state an intolerable one.” Compared to the abuses colonists faced from Britain in 1776, Americans today face a government far more evil and increasingly fatal to its citizens.

The unconstitutional, evil Government of the United States of America funds gain of function research and releases instructions for anyone to create more deadly viruses. They give money to potential enemies like China to help them develop deadly new viruses. They lie about the inevitable H5N1 pandemic coming (partly due to this gain of function research), and refuse to warn or prepare Americans for this inevitable, potentially imminent, deadly pandemic and the collapse that will result. They refuse to harden our fragile electric grid that is vulnerable to destruction by thousands of enemy agents in the country, solar flares, cyber-attacks, or small nuclear attacks that North Korea, China, or Russia can easily execute. Despite experts warning that 90% of Americans could die, the campaign donations of utility company lobbyists and fear of losing votes from higher electric rates keeps career politicians from doing the right thing.

The failure to secure borders—allowing enemy agents, terrorists, released prisoners, over ten million undocumented illegals, easy access to the country is explained by pandering for domestic Hispanic votes and businesses who like cheap undocumented labor. Domestic political priorities, Model 3, explains the risk of nuclear war with China by backing Taiwan despite China’s legitimate claim, and risking war with Russia by pushing NATO membership to Russia’s border despite Russia’s clear threats of retaliation. Our government funds and promotes AI despite clear evidence that it will lead to more weapons of mass destruction and inevitable misuse to kill millions or all of us. Battlefield nuclear weapons were unilaterally eliminated, endangering troops deployed overseas for domestic political votes at home.

Our government provides collapse survival protection for top elected and government officials at Mount Weather and other sites—but provides no civil defense for citizens. The Eisenhower and Kennedy Administration civil defense program of stockpiled food and exercises for citizens was abandoned as the Perverted Triangle gained unlimited power in the 1960s, leaving no preparations for citizens to survive a collapse. Worse, Continuity of Government policies will transfer police and military resources to protect top officials and politicians in a collapse—leaving less help for citizens. Not only are there no provisions for protecting citizens in a collapse--Executive Orders authorize Government agencies to seize food and resources from citizens in a collapse. The

Democratic Party, the worst part of the Perverted Triangle promotes laws limiting magazine size and attempts to ban AR-15s and “military capable” weapons that citizens need in a collapse to defend against marauder groups.

The unconstitutional, unlimited cesspool of regulations at all levels of governments don't just damage the economy and inflict losses that cost people jobs and lifespan, they make it increasingly harder for civilians to prepare for collapse survival. They hinder or stop small farms and domestic gardening/ranch animal husbandry vital to collapse survival. Zoning and building regulations violate our Constitutionally protected Natural Rights to private property and make it difficult or impossible to prepare for collapse survival. Unconstitutional regulations and taxes crush small businesses, making it harder to escape poverty, homes unaffordable, raising divorce and suicide from the economic stress of high taxes and high costs imposed by unlimited government spending and regulation.

Model 4, the Perverted Triangle, is the only way to explain government forest and wildfire mismanagement, pleasing environmentalists but setting us up for massive, deadly wildfires. When fires start, the unionized government firefighters first focus on preventing volunteer help to stop wildfires, preferring to maximize firefighter jobs and pay rather than stop fires and avoid loss of life. Pandering for votes from astronomers and NASA leads to government spending and programs to broadcast messages and send satellites beyond our galaxy to advertise and map our presence so alien civilizations more advanced than us can find us and likely exploit or exterminate us..

The Perverted Triangle has approved a multitude of unconstitutional, divisive social programs that benefit them, but divide the nation and threaten civil war. The socialist, welfare state the Perverted Triangle has built undermines marriage and families, promoting a subservient, irresponsible populace, higher crime, long-term poverty and dependence, and a higher domestic homicide death rate. Big Government overspending is driving national debt to a level that will bankrupt the country and lead to an economic collapse. Millions of government social and welfare workers are hired because they generate votes--while not enough police or Army National Guard members for peacetime security or collapse recovery operations are funded since there is no big lobby group and campaign donations behind them.

Regulations on food and drugs violate the Constitution and Natural Rights, misleading people into using unhealthy drugs and foods that benefit special interests and big companies at the expense of health and lifespan. Murderers and criminals are freed by a legal system corrupted by the Perverted Triangle to maximize profit for lawyers; lawyers allowed to lie in Court, no priority for truth, Natural Rights, or Justice. The unconstitutional, ineffective “War on Drugs” has not stopped drugs but benefits the Perverted Triangle's power at the cost of higher taxes, crime and murder rates for Americans.

Many career politicians are unwilling to take action to secure our borders fearing loss of votes from the large Hispanic population, many of whom regard criticism of illegal immigrants as racist. Many

businesses lobby elected officials to allow illegal immigrants into the country for low cost labor. Our government has known of the risks from open borders for decades, and with the exception of President Trump, none have taken significant or successful action to reduce this risk.

These examples of our government pursuing policies that kill us make sense only in the context of benefiting the Perverted Triangle (Model 4), which prioritizes their political power at the expense of our welfare and lives, stealing our Natural Rights, violating the Constitution.

The NIH was banned from funding Gain of Function research in 2014, but effectively evaded the temporary U.S. ban by funding overseas research, including the Wuhan Lab, the likely source of the Covid-19 virus that killed over one million Americans. It seems inconceivable that a U.S. Government agency could consider giving funds to a potential enemy like China—but remember Allison’s Model 2: government agencies promote their interests and many sincerely believe that any medical research can be valuable. Since U.S. government no longer has any effective limits to what they can do, the 9<sup>th</sup> and 10<sup>th</sup> amendments wrongly but effectively erased by the Supreme Court, government bureaucrats believe and act as if they can do whatever they want.

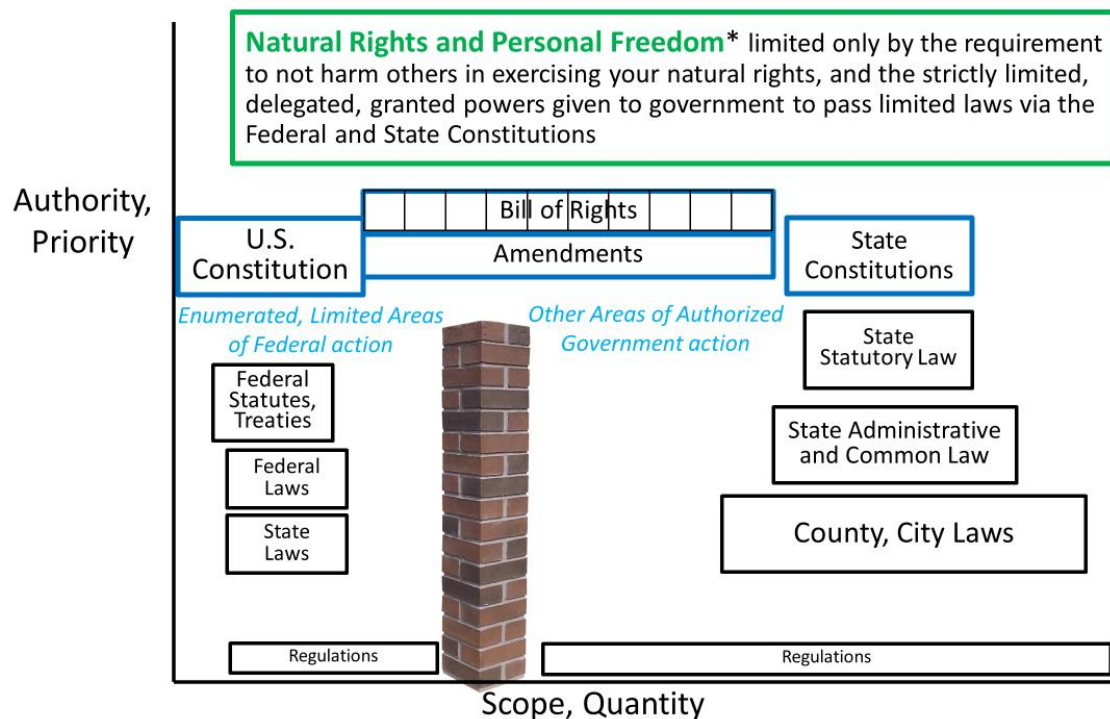
Congressmen do not want to kill 90% of Americans, but most prioritize their reelection and are constantly working to get donations—not figuring out how to best protect American lives (Model 3). Utility companies do not want to be forced to work and spend on hardening the grid, so they buy votes of career politicians. And since a vote to harden the grid will raise electric bills and cost them re-election votes, legislators don’t require this vital measure and we are set up for catastrophe.

As a result of Perverted Triangle (Model 4) promotion of laws, regulations and business for lawyers, the US ranks at the top of countries with the highest per capita rate of imprisonment. The nation founded as the land of the free, with Natural Rights protected by a Constitution with absolute limits on government power, the champion of liberty, has been corrupted and perverted into a land of government and lawyer theft and abuse. America is no longer the land of the free. The Perverted Triangle has turned the United States into the biggest police state in the world. Rational, best for the country analysis and decision-making, is sacrificed to the interests of the Perverted Triangle. Natural Rights are gone, ignored by the Courts, and Governments at all levels are free to abuse and (largely indirectly) kill citizens.

The state of our un-constitutional, un-American government and legal system is unbearable, and increasingly un-survivable. With growing threats from new technologies, the Age of Collapse that could kill most of us, fixing our government and getting federal and state governments focused on avoiding disasters and surviving a collapse is especially vital now.<sup>cxiii</sup>

The Constitution was never amended by the People or the States to eliminate our Natural Rights of privacy, private property, and self defense—all protected by the 9<sup>th</sup> Amendment that the Supreme Court now refuses to enforce. The U.S. is not a democracy or a representative democracy with unlimited majority rule, it is a Republic with a Constitution that guarantees our individual Natural Rights and protects us from abuse of the majority or government by greatly limiting government to just the specific areas where federal government is authorized to rule, with all levels of government limited in abusing our Natural and Constitutional Rights.

The right of personal use of your private property that has no impact on neighbors (often none, or not in view or even shouting distance) is increasingly restricted or completely denied by Big City regulations that Democratic Party controlled Big State Government has forced into county government and rural areas. In the interests of survival, preppers looking to build their bug out facilities and survival communities in rural areas should ignore the zoning and building code barriers that stand in the way.

The Nanny State illegally dictates what we consume, regulates drugs and birth control, how we invest, the placement of outlets in our house, spacing of our stair balusters — but can't be bothered to warn or prepare its citizens to survive the coming pandemic, harden the electric grid, or stockpile transformers so we can repair damage to the electric system in weeks rather than months or years. We don't have limited, Constitutional Government in the United States, or Responsible Government that provides security while staying out of personal affairs. We have Big Government abusing power in areas where it has absolutely no business being involved, trampling individual rights and freedom, violating the U.S. Constitution—ignoring the national security threats that could kill us, and blocking our ability to prepare.

American Citizens before FDR did not need help with healthcare, or income, or social services; they had individual responsibility and families. Churches and private charities existed and served long before FDR and the Perverted Triangle built the socialist welfare state.<sup>cxiv</sup> What we do need is a

recovery of the Natural Rights America fought a Revolution to secure, then approved a Constitution to protect. What we do need Government for is to protect us against threats we can't handle on our own—criminals, foreign enemies, and increasingly deadly new technologies that enable anyone to cause devastation that can kill us.

With rapidly growing threats from new technologies, fixing our government and getting Federal and State governments focused on their proper, limited mission of protecting citizens against threats they cannot handle on their own is vital in the “Age of Collapse.” Today, a small group or even an individual can create a new virus, or take down the electric grid. A small nation can create a nuclear weapon, and with AI enabling new means of enriching uranium, we may reach the point where small terrorist groups can also do so. Artificial Intelligence, Nanotechnology, Genetically Modified Organisms, cyber-attacks, other new technologies keep adding to the probability that our grid will go down, economy won't function, crops and wildlife will be destroyed, and most of us killed with our complex, just in time delivery (few inventories or stockpiles) economy.

With a future of deadly bioengineered pandemics, a vulnerable electric grid our irresponsible federal and state governments refuse to harden, and other threats from old natural phenomenon and new man-made technologies, U.S. Government must stop wasting resources on social and welfare policies that divide the nation and return to its original, constitutional limited top priority of protecting citizens from external threats they cannot handle on their own.

At Fortitude Ranch, the survival community I founded, if any government officials or forces come to steal our weapons, food, ammunition or resources in a collapse, we will exercise our Natural Rights to survival and private property and not just refuse the order, but if necessary—treat them like any other marauder group attacking us, and deliberately kill government officials and soldiers attempting to steal our supplies. We would much rather die fighting to protect ourselves and our Constitutional, Natural Rights than starve to death.

The military and police are not our enemy. The vast majority of firefighters and government employees are good people. But they are controlled by the Perverted Triangle that must be stopped before their corrupt exercise of unconstitutional power gets us all killed.

In the Age of Collapse we will suffer severe disasters that kill off millions or billions of people because of new technologies and threats, our fragile, interdependent economic system, irresponsible government, and a population that is increasingly dependent. We need to shift not to Asia or the Pacific, but to homeland defense and collapse survival. The US military needs to abandon its world's policeman role, and focus on prompt global strike with conventional or nuclear attacks to interdict enemy WMD, with smaller overseas forces backed by a return of battlefield nuclear weapons, and most resources focused on homeland defense and collapse recovery capability so fewer citizens die when the WMD attacks cannot be prevented.<sup>cxv</sup>

In 2024 the Army National Guard's budget was just 2% of the massive \$825 billion U.S. defense spending. The Army National Guard has just 325,000 members, down in recent years--less than one tenth of one percent of the U.S. population. The Army Reserve is small, just 200,000 personnel (including civilians). There are less than 1.3 million law enforcement officers. There is some double count here—many Army Guard and Reserve troops are also local government LEOs. Adding in Marines and Air Force, we've got less than 1% of the population serving in the military or law enforcement. This is not nearly enough, given 1 million gang members in the U.S., 2 million Americans in jail who will get out in a collapse, and much or most of the population turning to marauding, killing if necessary, to try to survive during a collapse. We need a much larger Army

National Guard reserve and a big reserve force of LEOs. We have less than 100,000 reserve LEOs—we should have several million of them; recruited from retired military and LEO members, paid a low fee for regular training, equipped with small arms and protective gear.

Without an end to the Perverted Triangles unlimited power and focus on re-election and pandering for votes with pork and social programs rather than prioritizing national security, dividing our country, most Americans, and likely the vast majority of all humans around the world, are unlikely to survive the coming collapses.

We must get term limits, amendments to force the Supreme Court to enforce, not ignore the 9<sup>th</sup> and 10<sup>th</sup> Amendment, and other reforms to restore Natural Rights and the Constitution and destroy the Perverted Triangle. We need a second American Revolution, “The Constitutional Alliance,” to destroy the Perverted Triangle and bring back our Constitution and Natural Rights we fought the first revolution to secure. The way to save our country is Article V of our Constitution and a Convention of the States--the failsafe measure the Founding Fathers placed to enable citizens and states to fight back against a corrupt, unconstitutional government seizure of power. A Convention of the States can pass the Amendments needed to stop career politicians, the Court’s failure to enforce the 9th and 10th Amendments, restore our Natural Rights and limits to government activity, and adopt other measures to kill the Perverted Triangle. Until the 1930s, the federal government remained tiny, with a budget of less than \$40 billion. But after FDR forced the Supreme Court to ignore the 10th Amendment limits to federal programs, violating the Constitution, Big Government took off and the power of the Perverted Triangle exploded. Championed by the anti-Federalists in the Bill of Rights, approved by John Madison, Jefferson and Washington, the 10th Amendment was adopted to be an unassailable barrier to excessive federal government power by making it crystal clear that "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people." Unless the Constitution specifically grants and mentions a task for the federal government, it cannot pass laws or spend tax dollars for such unconstitutional programs.

Antifederalists like Mercy Otis Warren and George Mason objected to the risks of excessive federal power, leading to the Bill of Rights, including the critical 10th Amendment to the Constitution that clearly states that unless a power and area of governance is specifically granted in the Constitution the federal government can pass no laws. The Federal Government is charged with foreign affairs and defense, local matters were left to State Government and personal matters left to personal choice.

The "Federalists Papers," are the supreme, most respected guide to what the Constitution means. In Federalist Paper #45, written by the leading author of the Constitution, James Madison, we have this same absolutely clear explanation: "The powers delegated by the proposed constitution to the federal government, are few and defined. Those which are to remain in the state governments are numerous and indefinite. The former will be exercised principally on external objects, as war, peace, negotiation, and foreign commerce; with which last the power of taxation will for the most part be connected. The powers reserved to the several states will extend to all the objects, which, in the ordinary course of affairs, concern the lives, liberties and properties of the people; and the internal order, improvement and prosperity of the state." Madison reaffirmed this absolute limit on federal government powers and taxes again in 1800 in a written report to Congress.

Jefferson called the 10th Amendment, which Democratic President FDR assaulted and the Chief Justices erased, the "foundation" of the U.S. Constitution: "I consider the foundation of the Constitution as laid on this ground: That 'all powers not delegated to the United States, by the Constitution, nor prohibited by it to the States, are reserved to the States or to the people.' To take a single step beyond the boundaries thus specially drawn around the powers of Congress, is to take possession of a boundless field of power, no longer susceptible of any definition."

In 1935 Franklin Roosevelt signed the Social Security act passed by a Democratic Party controlled Congress, a clearly unconstitutional program, having nothing to do with any of the enumerated powers in the Constitution. For years the Supreme Court had been striking down FDR's "New Deal" socialist programs as blatantly unconstitutional, violating the 10th Amendment, but they would operate for years until declared unconstitutional by the Court, passing on wealth and pork to millions of citizens and elected officials, corrupting the citizenry, undermining families and personal responsibility, and building up his political power. FDR threatened to "pack" the Supreme Court, increasing the number of Justices, with new appointees who would ignore the 10th. Leading public policy expert and political scientist Charles Murray published a brilliant book *By the People: Rebuilding Liberty Without Permission* that explains how the Supreme Court, under pressure from FDR threatening to force retirement of older Justices, with threats of strikes and violence in the country, suffering during the Great Depression, and condemnation of the Court, gave up enforcing the Constitution and effectively erased the 10th Amendment. In 1937, a majority of Justices surrendered to FDR and gutted the Constitution, eliminating the

---

10th Amendment limits on federal spending and laws. The 1937 decision in *Helvering v. Davis*, 301 U.S. 619, ruled that Social Security was constitutionally permissible as an exercise of the federal power to spend for the general welfare and so did not contravene the 10th Amendment of the U.S. Constitution. A majority of the Judges ruled that the “general welfare” phrase in effect gives Congress and the federal government the ability to fund and do whatever they want—directly violating and illegally deleting the 10th Amendment.

The rationale used in the 1937 *Helvering* case was a gross lie and deception, a blatant violation of the Supreme Court’s duty and the clear intent of the Constitution. As Murray explained, “The constitution wouldn’t have had a snowball’s chance in hell of being ratified if the Federalists had defended the interpretations of the General Welfare Clause and the Commerce Clause that revolutionized the Constitution in the twentieth century. The Constitution was ratified only because all of the leading Federalists vigorously rejected those interpretations during the debate over ratification . . . .”

A leading Constitutional expert, Roger Pilon, explained why this Supreme Court decision to ignore, erase the 10th Amendment was absolutely wrong:

“The centerpiece of the Constitution, again, is the doctrine of enumerated powers, which limits the federal government to its authorized ends. Consistent with that doctrine, as Madison, Jefferson, and others made clear, the General Welfare Clause could not have afforded Congress an independent power to spend for the general welfare; for under such a reading, Congress would be able to spend for any end, enumerated or not, provided only that it served the “general” welfare, and thus would be able to evade the limits imposed by enumeration. No, the clause was meant to serve as a shield against overweening power, not as a sword of power: it was meant to limit Congress’s spending for enumerated ends by requiring that spending be for the general rather than for any particular or local welfare. It was meant, in short, to limit Congress’s enumerated powers, not to undermine the doctrine of enumerated powers itself.”

There is absolutely no justification for a Supreme Court or any federal government official or organization to claim that an introductory phrase, “the General welfare” overrides or eliminates the 10th Amendment! The 10th Amendment was then and is still today absolutely clear as a rigid limit on federal government involvement. But a majority of frightened Supreme Court Justices in 1937-- facing a powerful President, Democratic Party controlled Congress, and a public that included many engaged in violent strikes and protests--lied, deceived and gutted the Constitution’s clear limits to federal government power. As a leading Cato Institute expert put it, the Constitution “was eviscerated by the New Deal Supreme Court following Franklin Roosevelt’s 1937 threat to pack the Court with six new members.”

The *Helvering* case surrender was quickly followed by other Supreme Court abdications of responsibility and the Constitution. FDR then appointed 5 young Supreme Court justices (all FDR backers, some former Democratic party Senators) pledged to allowing any government spending or programs. Within six weeks of *Helvering*, the Court ruled that the National Labor Relations Act was constitutional, ignoring the 10th Amendment and perverting the Interstate Commerce Clause to allow federal rules even when there was no interstate commerce. With the 10th Amendment now erased, the Commerce Clause was turned into “the everything clause” and the 9th Amendment that guarantees Natural Rights like private property and privacy and being left alone was also erased--Congress was illegally enabled to spend on anything and do almost anything they wanted! In effect, the Supreme Court quietly told Congress (the public and many in Congress never understood what was happening) that the federal government could ignore Constitutional limits, regulate any economic activity it wanted, redistribute income at will, legislate and spend on any social program or anything at all they wanted to do—a perfect arrangement to buy votes, just as FDR had so effectively.

Americans are 99% ignorant of how our Constitution and our Natural Rights were illegally erased by the FDR’s Supreme Court in the late 1930s. It is essential to understand what happened, and how our government and legal system was transformed into institutions not to limit government power, but empower the Perverted Triangle to trash American personal freedom, subvert families and individual responsibility, and build unlimited power for themselves via Big Government that profits them but has ruined our country. The next paragraphs, from Roger Pilon, who held senior posts in the Reagan administration and founded the Cato Institute’s Center for Constitutional Studies, explain how FDR and the Supreme Court eliminated our Natural Rights and ruined our Constitution.

“Having thus eviscerated the doctrine of enumerated powers, the Court turned next to the Bill of Rights, which it gutted in a now-famous footnote in a case called *Carolene Products* [in 1938]. Details of the case aside, the doctrine that emerged, which is the foundation of modern constitutional law, is this: we have two kinds of rights — “fundamental” rights, like the right to vote and the free-speech rights that are associated with the democratic

process; and “nonfundamental” rights, like rights of property and contract and rights associated with “ordinary commercial transactions.” When legislation or enforcement actions implicate the first category of rights, the Court will give those measures “strict scrutiny” and will most likely find them unconstitutional. By contrast, when measures implicate the second category of rights, they will be given minimal scrutiny by the Court: if they are “rationally related” to some “conceivable” government end, they will pass constitutional muster.”

“Needless to say, the floodgates were now almost fully opened. With the government’s redistributive and regulatory powers all but plenary [absolute] after 1937, only our rights could be posed as a brake on federal power. After *Carolene Products*, however, even that brake was eviscerated, for only if we could show that the rights implicated by a given measure were “fundamental” could we hope to get a court to review the matter. The value-laden distinction between two kinds of rights — to say nothing of the distinction between two levels of judicial review — is nowhere to be found in the Constitution, of course. It was written from whole cloth to pave the way for the redistributive and regulatory programs of the New Deal. Indeed, Rexford Tugwell, one of the principal architects of the New Deal, said as much some 30 years after *Carolene Products* was decided: “To the extent that these [New Deal policies] developed, they were tortured interpretations of a document [i.e., the Constitution] intended to prevent them.”

“With that, the Constitution truly stood on its head. As written, it is a document of enumerated powers, the exercise of which is limited by both enumerated and unenumerated rights. As it emerged from the New Deal, it was a document of effectively unenumerated powers, the exercise of which would thereafter be limited by rights interpreted narrowly by conservatives on the Court and episodically by liberals on the Court. In short order, that is, both sides would buy into the New Deal’s “democratization” of the Constitution — the expansion of public power over theretofore private affairs; the only differences they would have, for the most part, would be over whether there might be any rights to brake that power. Conservatives would have difficulty finding any rights not expressly in the Constitution, thus ignoring the plain language of the Ninth Amendment: “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people.” Liberals would ignore rights plainly in the document, such as rights of property and contract, while finding other “rights” not meant to be among even our unenumerated rights. That, in a nutshell, is the state of modern constitutional jurisprudence in America. The rewriting of the Constitution, without benefit of amendment, goes far toward explaining how political forces bent on expanding government have been able to do so in the face of a document written plainly to prevent that.”

Thus FDR and the Democratic Party, often backed by Republicans eager to also bring pork to their district to buy votes for their re-election, unshackled by the Constitution and our Natural Rights limits to government, passed welfare and social legislation that blatantly violates the 9th and 10th Amendments and completely ignores limits to government—the very purpose of the American Revolution and the Constitution! Congress routinely appropriates funds for programs that are absurd wastes and affronts to many Americans, in absolute violation of the 9th and 10th Amendments that are no longer followed, though never legally repealed. This is the fundamental, major reason why Texas and many other states, and divided parts of many more states, want to secede and get away from the abuse of power by the unconstitutional United States federal government. We thus refer to the current federal government as the unconstitutional United States, uUS.

How could this happen when the Ninth Amendment is so absolutely clear, both in its text and legislative intent: “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people”?

Of course, when people disagree, and court cases occur, Judges (and ideally juries) need to judge and decide what unenumerated Natural Rights should be protected, and whether a law or some other conflicting right should take priority. It is pointless, a fool’s errand to try and legislate every possible right and stupider yet to try and argue what is right or wrong based on arguing past case decisions by other judges. What makes sense is for Judges and Juries to decide—guided by the Declaration and the Constitution, the priority of Natural Rights and personal freedom, sacrificed only when we are interfering with other’s Natural Rights, imposing harm or a huge risk of causing great harm to others. And as Pilon points out, “the principles of adjudication are the same with all rights, enumerated and unenumerated alike. Thus, from both a textual and an adjudicatory perspective, judges must uphold our written Constitution by discovering and securing unenumerated rights, just as they must and do with enumerated rights.” What is completely unacceptable is ignoring our Natural Rights to maximum freedom and the absolutely key American principles of limited government.

“It was the doctrine of enumerated powers that was meant to constitute the principal defense against overweening government.” The problem wasn’t lack of votes in Parliament (which as a minority, would have had 1

---

little or no effect) but rather the “unrestrained majoritarian regime, as the Founders knew from their experience with English rule.” The Boston Tea Party participants objected to the tax on tea, not the fact that they didn’t have a representative in Parliament to vote on it. The Revolution was not launched to gain seats in Parliament, but to proclaim a totally new type of government where The People had Natural Rights that were above and superior to any legislatures, God or king’s claim of authority. But its far better for the Perverted Triangle to have a docile, subservient population that blindly obeys and submits, so they teach in public history books that the Revolutionary War was just because of “taxation without representation,” and now that Americans can vote, government is good, FDR was the greatest American ever, businesses and greed and rich people are evil. The Perverted Triangle would love citizens to limit their involvement to voting, with elections limited to the Democratic Party and GOP, and blindly obey all laws. They champion “rule of law”—but most federal laws are unconstitutional, and a massive, ever-growing avalanche of laws and regulations have destroyed most of our freedom and are ruining our country.

The 9th and 10th Amendments are still there; but Congress, the Executive Branch and Courts are free to ignore them whenever they want. Worse, with the perversion of stare decisis and lawyers über alles, Judges follow and weigh past case decisions over both our superior Natural Rights and the Constitution! Most Americans know our government and judicial system are grossly wrong, but have no idea how the Perverted Triangle took most of their liberties and protection from Big Government.

The FBI and intelligence officials have been providing limited warnings about the growing terrorist and other threats to the U.S., but usually prefer to avoid alarming the populace or making elected officials look bad, so they understate the risks. Former officials are giving far more detailed and honest threat warnings.

In recent years tens of thousands of illegal Chinese immigrants, many young males, entered the U.S. illegally. Many are believed to be Chinese agents. Via other sources we know that the FBI has warned that China has safehouses for their agents in every state.

We can’t know their numbers, but it is likely several thousand. Some evidence of their presence is the 224 reported instances of Chinese espionage in the United States since 2000—but this does not capture the likely far more numerous cases of undetected espionage or agents that are not risking discovery by engaging in espionage, but working in a “normal” job, waiting for future assignment.

A recent FBI Director called the number of Russian spies in the U.S. “way too big” despite efforts to find them, but the FBI does not provide an estimate of their number.

There is an estimate of the number of ISIS members in the U.S.: over 1,000, in all 50 states. Since 2014, more than 250 individuals have been charged with ISIS-related activities.

Sarah Adams, a former CIA counter-terrorism analyst, who continues to access vast open-source material, recently warned that Al Qaeda (now led by the late Osama Bin Ladens sons) is in the operational phase of a plan to attack the U.S., both our Embassies abroad and coordinated attacks inside the U.S. itself. According to Adams, Al Qaeda has trained about 1,000 operatives to carry out attacks. A large portion of Al Qaeda agents infiltrated through our largely open northern and southern borders, but they also use legal methods of immigration. We don’t have any reliable information on the number of Iranian and North Korean agents in the U.S., likely relatively few. Would they coordinate with Russia and Chinese agents? Unlikely due to security concerns, but if there is a major attack on the U.S. by foreign agents that severely damages our electric grid (the likely target), they will probably be tasked to take advantage of U.S. disruption and widespread loss of law and order, to undertake attacks.

The former will be exercised principally on external objects, as war, peace, negotiation, and foreign commerce; with which last the power of taxation will for the most part be connected. The powers reserved to the several states will extend to all the objects, which, in the ordinary course of affairs, concern the lives, liberties and properties of the people; and the internal order, improvement and prosperity of the state." Madison reaffirmed this absolute limit on federal government powers and taxes again in 1800 in a written report to Congress.

Jefferson called the 10th Amendment, which Democratic President FDR assaulted and the Chief Justices erased, the "foundation" of the U.S. Constitution: "I consider the foundation of the Constitution as laid on this ground: That 'all powers not delegated to the United States, by the Constitution, nor prohibited by it to the States, are reserved to the States or to the people.' To take a single step beyond the boundaries thus specially drawn around the powers of Congress, is to take possession of a boundless field of power, no longer susceptible of any definition."

In 1935 Franklin Roosevelt signed the Social Security act passed by a Democratic Party controlled Congress, a clearly unconstitutional program, having nothing to do with any of the enumerated powers in the Constitution. For years the Supreme Court had been striking down FDR's "New Deal" socialist programs as blatantly unconstitutional, violating the 10th Amendment, but they would operate for years until declared unconstitutional by the Court, passing on wealth and pork to millions of citizens and elected officials, corrupting the citizenry, undermining families and personal responsibility, and building up his political power. FDR threatened to "pack" the Supreme Court, increasing the number of Justices, with new appointees who would ignore the 10th. Leading public policy expert and political scientist Charles Murray published a brilliant book *By the People: Rebuilding Liberty Without Permission* that explains how the Supreme Court, under pressure from FDR threatening to force retirement of older Justices, with threats of strikes and violence in the country, suffering during the Great Depression, and condemnation of the Court, gave up enforcing the Constitution and effectively erased the 10th Amendment. In 1937, a majority of Justices surrendered to FDR and gutted the Constitution, eliminating the

10th Amendment limits on federal spending and laws. The 1937 decision in *Helvering v. Davis*, 301 U.S. 619, ruled that Social Security was constitutionally permissible as an exercise of the federal power to spend for the general welfare and so did not contravene the 10th Amendment of the U.S. Constitution. A majority of the Judges ruled that the “general welfare” phrase in effect gives Congress and the federal government the ability to fund and do whatever they want—directly violating and illegally deleting the 10th Amendment.

The rationale used in the 1937 *Helvering* case was a gross lie and deception, a blatant violation of the Supreme Court’s duty and the clear intent of the Constitution. As Murray explained, “The constitution wouldn’t have had a snowball’s chance in hell of being ratified if the Federalists had defended the interpretations of the General Welfare Clause and the Commerce Clause that revolutionized the Constitution in the twentieth century. The Constitution was ratified only because all of the leading Federalists vigorously rejected those interpretations during the debate over ratification . . . .”

A leading Constitutional expert, Roger Pilon, explained why this Supreme Court decision to ignore, erase the 10th Amendment was absolutely wrong:

“The centerpiece of the Constitution, again, is the doctrine of enumerated powers, which limits the federal government to its authorized ends. Consistent with that doctrine, as Madison, Jefferson, and others made clear, the General Welfare Clause could not have afforded Congress an independent power to spend for the general welfare; for under such a reading, Congress would be able to spend for any end, enumerated or not, provided only that it served the “general” welfare, and thus would be able to evade the limits imposed by enumeration. No, the clause was meant to serve as a shield against overweening power, not as a sword of power: it was meant to limit Congress’s spending for enumerated ends by requiring that spending be for the general rather than for any particular or local welfare. It was meant, in short, to limit Congress’s enumerated powers, not to undermine the doctrine of enumerated powers itself.”

There is absolutely no justification for a Supreme Court or any federal government official or organization to claim that an introductory phrase, “the General welfare” overrides or eliminates the 10th Amendment! The 10th Amendment was then and is still today absolutely clear as a rigid limit on federal government involvement. But a majority of frightened Supreme Court Justices in 1937-- facing a powerful President, Democratic Party controlled Congress, and a public that included many engaged in violent strikes and protests--lied, deceived and gutted the Constitution’s clear limits to federal government power. As a leading Cato Institute expert put it, the Constitution “was eviscerated by the New Deal Supreme Court following Franklin Roosevelt’s 1937 threat to pack the Court with six new members.”

The *Helvering* case surrender was quickly followed by other Supreme Court abdications of responsibility and the Constitution. FDR then appointed 5 young Supreme Court justices (all FDR backers, some former Democratic party Senators) pledged to allowing any government spending or programs. Within six weeks of *Helvering*, the Court ruled that the National Labor Relations Act was constitutional, ignoring the 10th Amendment and perverting the Interstate Commerce Clause to allow federal rules even when there was no interstate commerce. With the 10th Amendment now erased, the Commerce Clause was turned into “the everything clause” and the 9th Amendment that guarantees Natural Rights like private property and privacy and being left alone was also erased--Congress was illegally enabled to spend on anything and do almost anything they wanted! In effect, the Supreme Court quietly told Congress (the public and many in Congress never understood what was happening) that the federal government could ignore Constitutional limits, regulate any economic activity it wanted, redistribute income at will, legislate and spend on any social program or anything at all they wanted to do—a perfect arrangement to buy votes, just as FDR had so effectively.

Americans are 99% ignorant of how our Constitution and our Natural Rights were illegally erased by the FDR’s Supreme Court in the late 1930s. It is essential to understand what happened, and how our government and legal system was transformed into institutions not to limit government power, but empower the Perverted Triangle to trash American personal freedom, subvert families and individual responsibility, and build unlimited power for themselves via Big Government that profits them but has ruined our country. The next paragraphs, from Roger Pilon, who held senior posts in the Reagan administration and founded the Cato Institute’s Center for Constitutional Studies, explain how FDR and the Supreme Court eliminated our Natural Rights and ruined our Constitution.

“Having thus eviscerated the doctrine of enumerated powers, the Court turned next to the Bill of Rights, which it gutted in a now-famous footnote in a case called *Carolene Products* [in 1938]. Details of the case aside, the doctrine that emerged, which is the foundation of modern constitutional law, is this: we have two kinds of rights — “fundamental” rights, like the right to vote and the free-speech rights that are associated with the democratic

process; and “nonfundamental” rights, like rights of property and contract and rights associated with “ordinary commercial transactions.” When legislation or enforcement actions implicate the first category of rights, the Court will give those measures “strict scrutiny” and will most likely find them unconstitutional. By contrast, when measures implicate the second category of rights, they will be given minimal scrutiny by the Court: if they are “rationally related” to some “conceivable” government end, they will pass constitutional muster.”

“Needless to say, the floodgates were now almost fully opened. With the government’s redistributive and regulatory powers all but plenary [absolute] after 1937, only our rights could be posed as a brake on federal power. After *Carolene Products*, however, even that brake was eviscerated, for only if we could show that the rights implicated by a given measure were “fundamental” could we hope to get a court to review the matter. The value-laden distinction between two kinds of rights — to say nothing of the distinction between two levels of judicial review — is nowhere to be found in the Constitution, of course. It was written from whole cloth to pave the way for the redistributive and regulatory programs of the New Deal. Indeed, Rexford Tugwell, one of the principal architects of the New Deal, said as much some 30 years after *Carolene Products* was decided: “To the extent that these [New Deal policies] developed, they were tortured interpretations of a document [i.e., the Constitution] intended to prevent them.”

“With that, the Constitution truly stood on its head. As written, it is a document of enumerated powers, the exercise of which is limited by both enumerated and unenumerated rights. As it emerged from the New Deal, it was a document of effectively unenumerated powers, the exercise of which would thereafter be limited by rights interpreted narrowly by conservatives on the Court and episodically by liberals on the Court. In short order, that is, both sides would buy into the New Deal’s “democratization” of the Constitution — the expansion of public power over theretofore private affairs; the only differences they would have, for the most part, would be over whether there might be any rights to brake that power. Conservatives would have difficulty finding any rights not expressly in the Constitution, thus ignoring the plain language of the Ninth Amendment: “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people.” Liberals would ignore rights plainly in the document, such as rights of property and contract, while finding other “rights” not meant to be among even our unenumerated rights. That, in a nutshell, is the state of modern constitutional jurisprudence in America. The rewriting of the Constitution, without benefit of amendment, goes far toward explaining how political forces bent on expanding government have been able to do so in the face of a document written plainly to prevent that.”

Thus FDR and the Democratic Party, often backed by Republicans eager to also bring pork to their district to buy votes for their re-election, unshackled by the Constitution and our Natural Rights limits to government, passed welfare and social legislation that blatantly violates the 9th and 10th Amendments and completely ignores limits to government—the very purpose of the American Revolution and the Constitution! Congress routinely appropriates funds for programs that are absurd wastes and affronts to many Americans, in absolute violation of the 9th and 10th Amendments that are no longer followed, though never legally repealed. This is the fundamental, major reason why Texas and many other states, and divided parts of many more states, want to secede and get away from the abuse of power by the unconstitutional United States federal government. We thus refer to the current federal government as the unconstitutional United States, uUS.

How could this happen when the Ninth Amendment is so absolutely clear, both in its text and legislative intent: “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people”?

Of course, when people disagree, and court cases occur, Judges (and ideally juries) need to judge and decide what unenumerated Natural Rights should be protected, and whether a law or some other conflicting right should take priority. It is pointless, a fool’s errand to try and legislate every possible right and stupider yet to try and argue what is right or wrong based on arguing past case decisions by other judges. What makes sense is for Judges and Juries to decide—guided by the Declaration and the Constitution, the priority of Natural Rights and personal freedom, sacrificed only when we are interfering with other’s Natural Rights, imposing harm or a huge risk of causing great harm to others. And as Pilon points out, “the principles of adjudication are the same with all rights, enumerated and unenumerated alike. Thus, from both a textual and an adjudicatory perspective, judges must uphold our written Constitution by discovering and securing unenumerated rights, just as they must and do with enumerated rights.” What is completely unacceptable is ignoring our Natural Rights to maximum freedom and the absolutely key American principles of limited government.

“It was the doctrine of enumerated powers that was meant to constitute the principal defense against overweening government.” The problem wasn’t lack of votes in Parliament (which as a minority, would have had 6

little or no effect) but rather the “unrestrained majoritarian regime, as the Founders knew from their experience with English rule.” The Boston Tea Party participants objected to the tax on tea, not the fact that they didn’t have a representative in Parliament to vote on it. The Revolution was not launched to gain seats in Parliament, but to proclaim a totally new type of government where The People had Natural Rights that were above and superior to any legislatures, God or king’s claim of authority. But its far better for the Perverted Triangle to have a docile, subservient population that blindly obeys and submits, so they teach in public history books that the Revolutionary War was just because of “taxation without representation,” and now that Americans can vote, government is good, FDR was the greatest American ever, businesses and greed and rich people are evil. The Perverted Triangle would love citizens to limit their involvement to voting, with elections limited to the Democratic Party and GOP, and blindly obey all laws. They champion “rule of law”—but most federal laws are unconstitutional, and a massive, ever-growing avalanche of laws and regulations have destroyed most of our freedom and are ruining our country.

The 9th and 10th Amendments are still there; but Congress, the Executive Branch and Courts are free to ignore them whenever they want. Worse, with the perversion of stare decisis and lawyers über alles, Judges follow and weigh past case decisions over both our superior Natural Rights and the Constitution! Most Americans know our government and judicial system are grossly wrong, but have no idea how the Perverted Triangle took most of their liberties and protection from Big Government.

1. A hacked computer system can be shut down or data stolen—but it is not going to result in the development of a new Weapon of Mass Destruction (WMD)
2. It has been demonstrated many times that it is fairly easy to trick the LLM to get around the obvious ill use intent prohibitions; this has been demonstrated on many occasions.
3. History of science, development is accidental discoveries for good and accidents that cause bad damage. The AI system may not know it is engaged in developing a new WMD unintentionally.
4. Very wrong to say that AI has no more knowledge/capability than people—it’s the ability to combine knowledge across areas we never thought of, approaches so counter intuitive we’d never think of that gives AI power to use existing knowledge to develop novel new ways; that’s why AI won in Go. Using existing research papers it is very likely that AI systems tasked to find better ways to improve the lethality of existing WMD and invent brand new ones will succeed.
5. AI clearly does learn; and already AI is learning and thinking in ways the developers, the top experts don’t understand. So how in the world can we trust that it won’t develop far better ideas for far more devastating, easier to create weapons of mass destruction?
6. Some will be able to dismantle the AI controls if the AI is not in a contained, controlled, isolated laboratory work environment.
7. As China just demonstrated, it is increasingly easy to develop AI models. Will soon reach the point that any terrorist group or dedicated individual can develop their own AI model, and direct it to find the best possible WMD to kill people
8. All of the above is before/without AGI added dimension of AI risk/threat

U.S. allies have been behind the creation of the IMF special drawing rights, that uses a bundle of currencies, further diluting the value of the US dollar. In a recession the dollar will further collapse in value until eventually the majority of trade settlements will be conducted in currencies other than the US dollar. When that occurs, everything we import will explode in costs and U.S. inflation will explode. At any time, some nation may decide to sell its dollar currency reserves due to fear of a pending U.S. default on its debt—and start a panic sell off that quickly collapses the value of the dollar. The continued, irresponsible growth of U.S. government debt has set the dollar up for a collapse that could be triggered in many ways, at any time.

We do have the best expertise on estimating your likely financial results, and otherwise would like to assist you, but this law and our legal system will screw us if we attempt to do so. DP LLC, the parent company of FR, has been profitable since 2020, but we cannot provide our financial data or assist you in estimating your likely financial returns due to bad regulations and worse lawyers. As any business operator with an IQ over 90 knows, the results of business are subject to great risks, uncertainty, and sometimes losses. If you don’t have experience running a business, research starting up a business and consult with smart business persons you know. This regulation advises you to consult with lawyers for business advice (and requires that we print this recommendation)—we think that is foolish. Work with people who have real business experience, and be conservative rather than optimistic in your estimates. Assume that things will go wrong, sales won’t grow as fast as you anticipate, etc. Please do not ask us for any help estimating your financial results as a franchisee. We would like to help you, but cannot due to the high risk of lawsuits due to horrible regulations and our legal system.” Franchisees would benefit from a disclosure and illustration of the range of expenses and earnings they may expect, subject to huge variations depending on hundreds, thousands of factors. A normal investment document would have this, but if you offer this guidance to a Franchisee you are inviting a lawsuit from attorneys who specialize in suing Franchisors, empowered by the Perverted Triangle’s unconstitutional federal law on business franchise.
